- 5/31/42: Captain A. D. WAID, USA, Died at 0800 this date: Diagnosis: Dysentery, Bacillary, Pneumonia, Broncho and Malaria. Buried along the North wall of the Hospital grounds. (Row 1-Grave 12) Officers and Hospital (Bldg No. 5)(Bldg No. 4) quarters established. Sanitary measures were instituted and work commenced on the following: Garbage pits dug; old latrines filled in; waste water ditches were cut into outside sewers; wash racks installed; the entire hospital buildings and grounds were policed. Much improvement was noted after the completion of these measures. Sick Officers quarters was established this date (26 patients) in the West end of Bldg No. 4. The hospital consisted of one large medical ward (Bldg No. 11, Soq, old Chapel) and the isolation unit.
- 6-3-42: Captain's R. G. DAVIS, MC, USN, L. J. ROBERTS, MC, USN. K. E. LOWMAN, MC USN AND W. H. WILTERDINK, SC USN departed for TARLAC at 0800 this date along with other high ranking Army Officers. WILSON, Henry E. A. Pvt USA died at 1115 this date. Diagnosis: Dysentery, Bacillary. Buried in the Hospital Plot. (Row 1-Grave 19) Dispensary moved and set up in Bldg No. 9. A request to the Japanese was made for proper food for the sick and increase of food for the working group.
- 6-10-42: Hospital census 233. LANNING, Lewis "H", Pvt. USA died at 1855 this date. Diagnosis: Malaria, Malignant tertian. Buried in the hospital plot. (Row 1-Grave 20) There are many patients in critical and serious condition. Morale among the patients and prisoner group seems much improved due the improved organization and segregation of the sick. Inspection of the camp was made by Captain Kusomoto.

4-5-43: Monthly sanitary report submitted to the Japanese this date.

4-10-43: Six (6) patients admitted from Lipa, Batangas, P.I. this date.

4-14-43: Four (4) patients admitted from Corregidor, P.I. this date. Nineteen (19) patients admitted from Pasay, P.I., all of these men are in urgent need of hospitalization and treatment. Charts and medical histories were furnished by Japanese this date with instructions for their completion. Patient census 653.

4-16-43: The two (2) men, guilty of stealing milk, were released from the brig by the Japanese this date.

4-17-43: Forty (40) patients admitted from Fort Stotsenburg, P.I. this date. Patient census 690. Local talent show held this date.

4-19-43: NEWMAN, I., Pvt. U.S. Army, ASN: Unknown, was brought to this hospital at 1800 from a Japanese prison Camp at Pasay, P.I. The deceased was killed at approximately 1030 this date at Nichols Field, when a land-slide occurred, covering this man. Cause of death: Injuries, Multiple, Extreme. Buried in hospital plot, Row #3, Grave #46. Four (4) patients admitted from Lipa, P.I. this date.

4-21-43: Eleven (11) patients admitted from Palawan, P.I. this date. A draft of forty-seven (47) patients, and five (5) well men were transferred to Cabanatuan, P.I. by the Japanese. An inspection of the hospital was made this date by Lieut. Gen. Moromoto, Imperial Japanese Army, head of Military Prison Camps of P.I. Motion picture program presented by the Japanese this date. Japanese news reels, cartoon comic strip, a short on midget car racing and an American picture "We go Fast" was presented. Patient census 656.

4-23-43: Three (3) patients admitted from Neilson Air Port this date. Eight (8) patients admitted from Palawan, P.I. Patient census 869.

4-25-43: Easter services were held in the Chapel this date.
