This will acknowledge receipt of your letter, dated 22 July 1947, requesting recognition of the Capangihan Company, 3rd CV Regiment, 86th Infantry, Cebu Area Command.

A special press release from Headquarters AFWESPAC, dated 1 February 1946, announced the closing date for acceptance of unit requests for recognition as 15 March 1946. This information was widely disseminated throughout the Philippines by press and radio and through municipal agencies. It is considered that all concerned had ample opportunity to prepare and submit unit applications prior to the announced closing date.

Your request, dated 22 July 1947, does not comply with the closing date, and cannot, therefore, be accepted.
