No I Mr. Silvino P. Miralles, the chief of the Intelligence Area V, 95th Infantry, 92nd Division, Leyte Area Command, informed me that in July, 1946, he sent to your Office the roster of said unit with the request that it be recognized. According to him, no action could be taken on it, in view of the fact that it was submitted late. Recently, however, I read from a press publication that recognition of guerrilla units and individuals has been extended to March 15, 1947.

✓ It is my hope and desire that my services and the services of my comrades in the resistance movement be recognized because the personnel in the unit to which I belonged, rendered even more difficult and risky services than those who were actually carrying arms in the guerrilla units, in view of the fact that we were exposed to the enemy since we were operating in the occupied area. Besides that, the Intelligence Area V, was rendering highly satisfactory service to the Headquarters of the S-2, in furnishing the necessary data and information regarding the activities of the enemy.

? In this connection, therefore, I should like to request information from that Office as to the actual status of the request for recognition of the Intelligence Area V, as requested by our chief, Mr. Silvino P. Miralles.

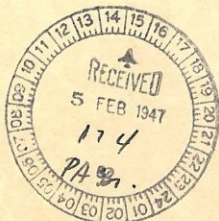
