MINUTES OF THE MEETING OF COMMANDING OFFICERS OF
DESERVING CIVILIAN GUERRILLAS OF DAGAMI,
LEYTE, HELD AT DAGAMI, LEYTE ON AUG-
UST 15, 1947.

R E S O L U T I O N

WHEREAS, there are still thousands of deserving
civilian guerrillas who are not yet recognized;

WHEREAS, the resistance movement in Leyte, was
made effective because of the valuable services ren-
dered by the civilian guerrillas;

WHEREAS, it will be injustice to those civilian
guerrillas who have rendered full military services
if they will not be recognized;

BE IT RESOLVED THEREFORE, as it is hereby resol-
ved by this body, to petition as it is hereby peti-
tioned to PHILRYCOM to recognize the different Units
of the Guerrilla Organization of the municipality of
Dagami, which was attached to "K" Co. and "I" Co., 95th
Inf. Reg., 92nd Division, (GUERRILLA) Leyte Area Com-
mand, of which Regiment was under the command of Ma-
jor Alejandro Balderian, for the sake of justice for
which many of our countrymen have died for the cause
of Democracy.

BE IT RESOLVED FURTHER, that a copy of this re-
solution be furnished, His Excellency, the President
of the Philippines, the Hon. President of the Senate,
the Hon. Secretary of National Defense, the Hon. Re-
presentative for the 5th District for Leyte and to
Major Alejandro Balderian.

Dear Mr. Domilon:

This will acknowledge receipt of your letter, dated 6 March 1947, in which you forward a roster in triplicate of the Volunteer Guards, Unit V, Division I, Dagami Area Command and request recognition.

Special press release from Public Relations Office, AFMESPAC, dated 1 February 1946, stated that no applications for recognition of guerrilla units would be accepted by this headquarters after 15 March 1946. Your request for recognition of the Volunteer Guards, Unit V, Division I, Dagami Area Command, was received at this headquarters in your letter dated 6 March 1947, and does not meet the deadline referred to above. The recent press release from Public Relations Office, PHILRYCOM, referred to the final date of 15 March 1947 for the submission of individual non-casualty application for recognition.

It is generally considered that all concerned have had ample opportunity to prepare unit applications for recognition. In the opinion of this headquarters, your request for an extension of the time limit mentioned above is not adequately justified and therefore, is not favorably considered.
