Receipt is acknowledged of your letter dated 28 March 1946.
Subject: "Request for Recognition of Tolosa Area Command Unit."

Special press release from Public Relations Office, AFWESTPAC, dated 1 February 1946, stated that no applications for recognition of guerrilla units will be accepted by this headquarters after 15 March 1946. This press release was given wide circulation in newspapers and was also broadcast by local radio stations.

Your request for recognition of Tolosa Area Command unit was received at this headquarters in envelope postmarked 1 April 1946 and does not meet deadline referred to in paragraph 2, above.

It is considered generally that all concerned have had ample opportunity to prepare applications for recognition. In the opinion of this headquarters, an extension of the time limit mentioned above is not justified in your case and therefore is not favorably considered.

By way of your information about me I am former Com. officer of Tolosa Area Command here, under Major A. Balderian and Ruperto Kangleon Col. I served as Captain Guirrella in Sept 10, 1942 and reverted to Civil status July 15, 1944 without further investigation. I am Philippine Scouts Station Fort Mills Corregidor and I have excellent discharge. I have not done wrong to my superior, nor to my sector, and during Japs occupation I protect the lives and property of the people, I maintained Peace and order, and fight the principles objectives of democracy, and during your landing still I serve for our cause.

When the fight in heyte was over I reported to Col. Taylor
Detact. Cammander of the U.S.A.F.F. he told us to report to you in
Tacloban but you moved out, so I Proceeded to American Red Cross
and served for 14 months as Employee. I hope the General will
help me of my case. Some Gurrilla Received pay who even did
not sacrifice for the cause. I have plenty of men during
your landing who sacrifice and are asking me where they
Get their pay, I told them to wait for the order of Higher Command,
Hoping for your help.
