Dear Miss Villajuan:

This will acknowledge receipt of your letter, dated 20 May 1947, in which you repeat your request for recognition of the roster of the Pantabangan Guerrilla First Aider.

As you were informed in a letter, this headquarters, dated 8 May 1947, in answer to your similar request made on 31 April 1947, a special press release from Public Relations Office, AFWESPAC, dated 1 February 1946, stated that no applications for recognition of guerrilla units would be accepted by this headquarters after 15 March 1946. The recent press release from Public Relations Office, PHILRYCOM, further announced the closing date of 15 March 1947 for the submission of individual claims for non-casualty recognition.

It is necessary to re-emphasize that this headquarters consider that all concerned had ample opportunity to prepare unit applications for recognition by 15 March 1946. Your request for recognition of the rosters of Pantabangan Guerrilla First Aider was first received by this headquarters on 26 April 1947. It does not comply with the above closing date and therefore cannot be accepted for consideration.

As you were previously informed, this decision does not preclude submission of claims for casualty recognition by those individuals who are qualified and feel justified in entering such claims. Upon request from interested individuals, appropriate forms will be forwarded.

It is again necessary to return to you the roster of Pantabangan Guerrilla First Aider.
