Receipt is acknowledged of an affidavit made by Norman Thompson, dated 18 July 1946, and rosters of the Fil-American Guerrillas, Taal-Lemery. It is assumed by this Headquarters that this constitutes a request for recognition of your unit.

Special Press Release from Public Relations Office, AFMESPAC, dated 1 February 1946, stated that no applications for recognition of guerrilla units would be accepted by this Headquarters after 15 March 1946. The affidavit of Norman Thompson and the rosters of your unit were received at this Headquarters on 27 July 1946. This does not meet the deadline referred to above.

It is generally considered that all concerned have had ample opportunity to prepare applications for recognition. In the opinion of this Headquarters your assumed request is not adequately justified and therefore, is not favorably considered.
