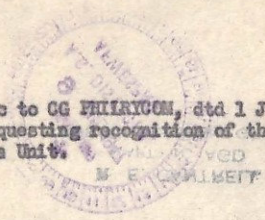

S i r :

I have the honor to request for recognition of our Unit which was engaged in anti-Japanese during the Resistance movement in Western Coast of Pangasinan under Lieut. Teodere Miller (Pilot) who was a escape-American soldier, starting from August 1, 1943.

Our operation consisted of purely anti-Japanese activities, namely,

- a. We furnished information regarding Japanese activities to Lieut. Teodere Miller at his hide-outs.
- b. We furnished information concerning movements and concentration of Japanese troops.
- c. We harassed Japanese patrols.
- d. We looted Japanese supplies and stole several of their firearms and ammunitions.
- e. Participated with other Guerrilla Units in assaulting a Japanese Garrison in the municipality of Agno which resulted to the killing of two Japanese soldiers and the driving away from their garrison the rest of the Japanese soldiers.
- f. We protected civilians from robberies, abuses and other atrocities.

Due to the reports of their spies, our Unit was investigated and many of our members specially the leaders were taken to the Japanese Garrison and tortured almost all of our members by slapping, kicking, beating, whipping and giving water cure.

This application for recognition should have been submitted earlier but nobody knew how to prepare and how to course the necessary papers for recognition until very recently when a certain recognized guerrilla officer has hinted us the preparation and proper coursing of the papers. The other factor for the delay was the untimely death of our leader, Lieut. Teodere Miller, who unfortunately captured un-aware by a Japanese patrol in his hide-out and thus he could not prepare the papers before his death. Had he been able to survive the war, our Unit would have been one of the first to be recognized. Hence, we pray and implore that our request be given favorable consideration.

Enclosed you will find the complete roster of our Unit.
