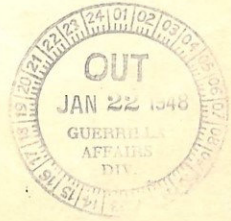



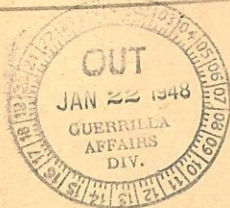

5. Upon receipt from his legal heirs of a claim for arrears in pay and allowances due his estate, authority for settlement thereof under existing laws and procedures will be furnished your headquarters by the Director, Recovered Personnel Division, this headquarters.

6. This roster will constitute the only official recognized casualty roster, Killed in Line of Duty of Squadron 203, Luzon Guerrilla Army Forces.
