We, the undersigned Usaffe Guerrillas respectfully submit this petition to yourhonorable, just and fair Office for action and consideration. For clarity of the various guerrilla activities we had shouldered, and for what this petition was made and submitted, allow us please to marrate to you few of the events that could testify or could be used as evidence.

During the National Emergency, we, as leval citizens of the Philippines, and more who are at heart with the principles of the United States Government, without being motivated by any personnel, unselfishly and willingly offered our services as Guerile las to gight and sacrifice our lives for the cause of our nation and the United States of America, despite of the fact that eur inducting officer then did not guarrantee the assurence of being granted benefits and compensation by the U.S. Government.

On August 5, 1942, we were inducted into the Usaffe Guerrilla Forces by Lt. Col. Edwin P. Ramsey, 26th Cav. UEA, then a last tt. 26th Cav. UEA, at Mount Eule, Porac, Fampanga, Philippines, in the presence of Major Francisco Ocampe Whe acted as interpreter to the sforementioned American Officer. We were assigned to the Sist Squadren, Capteln Micelas Laxa as sur Squadren Commander. This Squadren was the second among the Squadress erganized by the late Claude A. Therp, the Overall Commander of the Luzen Guerrilla Army Forces, officially authorized and designated by General Douglas Mac Arthur.

During our operation as guerrillas we were heavily armed with Jopanese Rifles and US Rifles. The same were gathered by us after the elapsed of the three nights fighting in our tawn Parac, Pampengs, Philippines, between the US Army soldiers and the invaders.

We, as members of the 51st Squadren are all residents of barts Babo Fengule, Porac, Fammanga, Philippines, a place where the Headquarters of the East Central Luzan Quartille Forces was established becaume of its strategia geographical lecation. During the period of stay of the said Headquarters in our barrie we acted as guards and furnished allied informations to the said Headquarters, the hide-out (Babo Pangulo) or the 51st Squadren became the contor of all cemmunications of all "nits cennected with the Usaffs Guarrilla, to wit: Henila Military District; Luzen Guarrilla Forces; and the 155th Squadren. Aside from the afforesaid activities, we served also as security guards of the Headquarters of the Sast Central Luzen Guarrilla when Lt, Cel. F. P. Remesy established the Headqua riers at Mts. Eddugem and

Cruz, also parts of Babo Pangulo, Porac, Pampanga, Philippines.

During the Regimental Formation of the Squadrons which were the under the Overall Command of Lt. Col. R. P. Remsey, our Squadron was designated as Company "IT, Srd Bn. 1st Regt. Worthwest Pampanga Military District, that was en October 10, 1942. Later, on September 28, 1944 the said Company was fused to Bonos

lition and Sabotage Unit, 6th Regt. Pampanga Military District in compliance with letter dated September 28, 1944, Subject: De-2-

molition and Sabotage Work, signed by Captain Hoge, Engineer Luzon Guerrilla Army Forces.

Upon arrival of the liberating forces we were attached to the 45rd Infantry Division, served as security guards and patrels; to the 374th Siglineer Avlation Battalion and also to the 22nd Sur-gleal Portable Hespital rendering the above ciced services and guides of the american soldiers to the foot hills and hide-outs where the Japanese soldiers were hidden.

On January 29, 1945, Lt. Hanley, Intelligence Officer of the Command Post Intelligence which was then stationed at Angeles, Command Post Intelligence which was then stationed at Angeles, Pampanga, Fhilippines investigated the Japanese soldiers killed by us at barrie Babe Pangule, Porse, Pampanga, Fhilippines, fow of them are still burried at Babe Pangule and some were burned to ashes as per order of our Senior Officer Major Francisco Comme. On March 15, 1945, another two Japanese soldiers were again killed by us in the same barrie. We encountered much difficulties during our guerrilla activities. We had struggled between life and death especially during our operation in dencishing and destroying the ammunition and geseline dumps and also Luesuan Bridge.

As to the roster of our unit, it was submitted in January 1945 to the Haadquarters, AFWESPAC by Lt. Col. Fabros, the Adju-tant General of the Fampanga MilitaryDistrict. Another rester that believed at the rampangs military puscifies, and one restr was submitted by Major Francisco Ceampo, Commanding Officer of the 6th Regt. Fampangs Military District, thru the 343rd Infantry Division, on March 14, 1946. The some rester was submitted persen-ally by Maj. Francisco Ceampo to Maj. Mc Gevern, the CO of the 34rd infantry Division which was then stationed at Angeles, Fampanga, Philippines.

Sometime in November 1946 our unit # DEMOLITION AND SABOTAGE UNIT" was interviewed by its. Morris Flory and Rivers, both mem-pers of the G-3, Guarrila Afriers Section, Philrycen, AFO 707. The two officers, after investigating the said unit, were on the spinion that its members deserves recegnition. Had it not been for billion that its managers deserves recognized in the terms of the spinish of these two offices, we had been recognized with the recognized members of the Northwest Pampanga Military District, because we are the original members of the Squadren 51 am eriginal Squadren of the Northwest Pampanga Military District, New 11 is a true fact, that the Squadron 51 is recognized with the NW PMD, but, we as original members who sacrificed for its foundation and success are not recognized, other persons that are inocent of the 51st Squadron and to its activities are recognized and had been granted compensation. There seems to be a miracle in the procedure.

For further references with regards to our activities, services to American stragglers and loyalty to the United States of American, we gladly refer your good office to the following persons, to wit:

- Pores, Panganga, Philipsines. 9. Captain Orane and Lt. Gardner-who stayed with us du-ring our operation for almost a year. These two efficer, we gave everything thay asked for, we constructed a dwelling house for them near the feet hill of Babe Pangulo in our own expenses.
- 10, Cel. Jose B. Lingade Executive Officer of the Pamyanga Military District and at present Governor of Pampanga province.

In view of the foregoing facts, we hereby request that our Unit shall be given consideration, inasmuch as weas Usaffe Guerrillas performed our duties in the best military tradition for the cause of the Fhilippine Gevernment and mere to the United States of America. We further request that investigation must be conducted by persons in attherity to investigate our case at their earliest convenience because persons that are not original members of our unit are now recognized and received their due compensation, while we as original and benafide members of the 51st Squadren are not recognized.

Any favorable, prompt and fair action acted upon this pe-tition is highly appreciated by the undersigned Usaffe Guerrillas. We are.

That the 51st Squadron, NW PMD, ECLGA was later assigned as Demolition and Sabotage Unit against the enemy;

That during the liberation, Commander Nicelas Laxa and his men were attached to different American Outfits where we were attached until released:

That all the members of the 51st Equadron were original members of the Northwest Penmanga Military District, ECLGA, but due to the agreement of the Tontset Team of the Guerrilla Affairs Section, AFWESPAC and Major Francisco Ocampo, former Chief of Staff, NW PMD, EGLGA, recog-nized Commanding Officer, 6th Regiment, Penmanga Military Dis-trict, ECLGA, Commender Nicelse Laxa and his mon were transfored to the 6th Regt., PMD, EGLGA, under Colenel Abelarde de Diss.

The undersigned, formerly commanding officer of the EAST CENTRAL LUZON GUERRILLA AREA, respectfully requests information as to any action which has been taken with regards to Squadrons 51 and 52 NORTHWEST FAMPANGA, SOLCA.

Sqdn. 52, under Tomas Lumenlan and Sqdn. 51, under Nicelas Laxa, were both erganized and inducted by the undersigned in August 1942, and were both well armed and active from the beginning being used as security troops while the Headquarters of ZCLGA, and Therp's Headquarters were in the mountains above Forac, Pampenga.

Sqdn. 51 was transfered to the 6th Regiment, Pam-Panga Military District, after the liberation, for operations, and is carried in the roster of that Regiment. This unit was investigated in the latter part of 1946, by Lts. Flory and Rivers. Until the present there has been ne action taken on this unit.

Sqdn. 52 submitted their restars at the Guerrilla Affairs Office on Juan Luna on 15 January 1946, to Capt. Graham and Lt. Tabora. These papers were lost in transit when the G A B Offices were moved and copies were resubmitted after the returndat we the undersigned to the Philippines in July 1946, at which time the undersigned made a strong recommendation in favor of this unit to Lt. Col. Carnaha.

The undersigned knows personally of the activities of the above-mentioned units and recommends favorable condideration on their requests.

That Commander Micolas Laxa together with his men were fully armed and acted as security guards of the BCLGA Headquarters in the mountains;

That the 51st Squadron, NW PMD, ECLGA was later assigned as Demolition and Sabotage Unit against the enemy;

That during the liberation, Commander Nicolas Laxa and his men were attached to different American Units where we were attached until released;

That all mambers of the Slat Squadron were original members of the Northwest Pamanaga Milltary District, BCLGA, but due to the agreement of Lt Morris Flory, a member of the Contact Team of the Guerrills Affairs Section, AFWESPA C and Major Francisco Commp, former Chief of Staff, NW FMO, SOLGA, recognized Commanding Offleer, 6th Regiment, Pampenga Military District, BCLGA, Commander Nicolzs Luxa and his men were transfered to the 6th Reg't., FMD, WOLGA, under Colonel Abelardo de Dios.

and his men That during the Liberation, Commander Nicolas Laxa/were attached to the CPI 43rd Inf Division, the 22nd Surgical Portable Haspital and acted as guides, guards and patrols in the enamy concentrations in the foot hills, and also attached to different american outfits where most of the men of the NW PAD were attached. This unit was transfered to 6th HD, for operations.

The undersigned, formerly commanding officer of the EAST CENTRAL LUZON GUERRILLA AREA, respectfully requests information as to any action which has been taken with regards to Squadrons 51 and 52 NORTH-WEST PANCAA, SCLGA.

Sqdn. 52, under Tomms Lumanlan and Sqdn 51, under Nicoles Lexa, were both organized and inducted by the undersigned in August 1942, and were both well armed and active from the beginning being used as security troops while the Headquarters of 2010A, and Thorp's Headquarters were in the mountains above Porac, Pampanga.

Sqdn. 51 was transferred to the 6th Regiment, Panpanga Military District, after the liberation, for operations, and is carried in the besters of that Regiment. This unit was investigated in the latter part of 1946, by Lts. Flory and Rivera, Until the present there has been no action taken on this unit.

Sqdn. 52 submitted their rosters at the Guerrilla Affairs Office on Juan Luna on 15 January 1946, to Capt. Graham and Lt. Tabora. These papers were lost in transit when the G A B Offices were moved and copies were resubmitted after the return of the undersigned to the Philippines in July 1946, at which time the undersigned made a strong recommendation in favor of this unit to Lt. Col Garnahan.

The undersigned knows personally of the activities of the above-mentioned units and recommends favorable consideration on their requests.

b. Accurate information as to the type of equipment, tanks if any, trucks, etc., and number in each locality.

c. All reports forwarded should be dated and certified by your moveratives as true as of the hour stated on the report. Copies of these reports should be given by your men to all American patrols that you are able to contact in your area.

d. It is also suggested that you assign several of your most competent men to station at the town and along the Porac-Angeles national road and give American patrols all available information and assistance by serving as guides and in any other way served the patrols as may be required.
