Ricardo Angeles Headquarters Ordnance General Supply Depot Office of the Depot Commander.

Dear Mr. Angeles:

The Commanding General has directed that you be informed that the Base Small Arms Maintenance Company, FAIT, purporting to be a guerrilla organisation under your nominal control, is not favorably considered for p recognition as an element of the Philippine Army.

A set of general requirements for guerrilla recognition, established by General MacArthur during the liberation of the Philippines, has been used as s guide in considering the record of this unit. After careful investigation and full consideration of all substantiating records and testimony of witnesses having pertinent knowledge, recognition of this guerrilla unit is not deemed to be warranted because of reasons mentioned below:

a. The unit was not maintained entisfactorily in the field in opposition to the enemy.

b. Activities of the unit did not contribute saturially to the eventual defeat of the enemy.

c. Adequate records were not maintained (names, ranks, dates of enliatment or joining, dates of promotions, and necessary related information).

It is requested that you comply with the provisions of Executive Order No. 68, by the President of the Philippines, dated 26 September 1945, copy attached.
