Dear Miss Luis:

This will acknowledge receipt of your letter, dated 4 May 1947 in which you request the status of the requests for recognition of two guerrilla units of which you were apparently a member.

The request for recognition of the Medical Service Battalion McKinley Division was not favorably considered for recognition by this headquarters on 16 January 1946. A request for recognition of the Medical Detachment, 4th Regiment, Fil-American Irregular Troops was not favorably considered by this headquarters on 31 April 1947.

A set of general requirements for guerrilla recognition, established by General MacArthur during the liberation of the Philippines, was used as a guide in considering the record of these units. After careful investigation and full consideration of all substantiating records and testimony of witnesses having pertinent knowledge, recognition of these guerrilla units was not deemed to be warranted.

REPORT ON MEDICAL DETACHMENT, FAIT, (ARAUULLO)

This officer, on 12 August 1945, under orders Chief, Guerrilla Affairs Section, U. S. Army Training Group, APPAC, interviewed Lt. Col. (Guerrilla Rank) Jose Encarnacion, commanding officer of the Medical Detachment, FAIT, which is claimed by Bonifacio Araullo as a unit under his overall command. The information gained during the course of the discussion is given in the following report, and is the basis for the recommendations submitted.

Organization

Jose Encarnacion, in the Guerrilla Unit Questionnaire submitted to the Guerrilla Affairs Office on 4 June 1945, stated that his organization consisted of one medical Battalion plus attached medical personnel. The total strength was given as six hundred forty-one (641) of which fifty-seven (57) are officers, and five hundred eighty four (584) are enlisted men.

History

Mr. Encarnacion stated that his organization was begun in August 1944, when he received orders from Bonifacio Araullo to form a medical unit. By the end of August, 1944, the unit consisted of one hundred (100) men. At this time, Mr. Encarnacion was employed as a professor at the College of Medicine, University of the Philippines. He continued his teaching, he says, and recruited men concurrently until January 1945, when his membership had reached six hundred forty (640). He states that his men did not operate as full time guerrillas. A few members of the unit worked at hospitals, others worked at the College of Medicine, University of the Philippines, and the remainder worked at their farms or at their private businesses. These men were, consequently, widely scattered and the battalion was never able to operate as such. He further asserted that only two (2) of his men had ever given aid to other guerrilla units. No personnel have been attached to U. S. Army organizations since 9 January 1945. All the above information was given this officer by Jose Encarnacion in a personal interview.

Recommendations

Because no part of the Medical Detachment, FAIT, commanded by Jose Encarnacion operated as a guerrilla unit during the Japanese occupation, and because no part of the organization has since been attached to U.S. Forces, I recommend that the unit not be recognized, and that no further investigation of this unit be made by the Guerrilla Affairs Office.

ADDENDA to the History of the MEDICAL CORPS  
FIL-AMERICAN IRREGULAR TROOPS

As an Officer of the Medical Corps of the Fil-American I Irregular Troops, Major Marcelino A. Asuzano hereby gives a brief account of the activities undertaken by him which are as follows:

1. About the middle of 1944, two American Officers of the Boone guerrilla unit operating in Bataan were under my medical care; both were suffering of malaria and malnutrition. On one particular occasion when I was giving them urea-quinine injections near a fish pond in Crani, a warning came that the Japs were on their way to raid the place so I had to rush the treatment. Quinine tablets were also furnished these Officers.
2. Medical supplies such as cotton, gauze, bandages, as well as medicines like tincture of iodine, alcohol, quinine tablets and urea quinine for injections were furnished to the Filipino members of the Boone guerrilla unit in Bataan.
3. Filipino members of the Boone guerrilla unit who were sick and also those who were wounded and need hospitalization were admitted in the emergency hospitals of the Bureau of Health located in Hermosa, Crani and Malanga through my intervention.
4. Through my initiative, voluntary contributions in the form of money and rice were collected from the Bureau of Health personnel and were given to needy members of the Boone guerrilla unit.

History of the MEDICAL CORPS.

On August 18, 1944, Captain Jose Encarnacion, Medical Reserve, U. S. Army, holder of Certificate of Capacity for Majority, was appointed Lieut.-Col., Medical Corps and designated by Gen. J. M. Bays, Commanding General of the Fil-American Irregular Troops to organize the Medical Corps of the FAIT. This unit was to include medical, dental, nursing and pharmaceutical services. So he had to contact men who were patriotic enough to join and send their names for appointment to the Commanding General of the FAIT. Many a time, Lieut.-Col. J. Encarnacion had to meet with disappointment because the people whom he approached were afraid to do guerilla work due to the vigilance and cruelty of the Japanese Military Police. This fact, however, did not deter him from continuing his hazardous work. So after several months, the nucleus of the Medical Corps of the FAIT was formed, comprising of about a hundred persons - Physicians, Dentists, Nurses, Pharmacists, and Technicians. A few of these gentlemen are reserve officers of the Medical and Dental Corps of the U. S. Army. Lieut.-Col. J. Encarnacion and Major Barican, both of the Medical Staff had to do the physical and medical examinations of the personnel of the other units of the FAIT. In the later part of 1944, the Commanding General of this Organization asked for a Medical Officer to go with him to Nagcarlang, Laguna, to bring medical supplies to our fighting unit in the Sierra Madre mountains, and Lieut. Reuben C. Balagot, M. C. was sent with him.

Lieut.-Col. J. Encarnacion, as the Commanding Officer of the Medical Corps, had to attend several secret meetings of the General Staff. At present, he is working for the U. S. Army as Director of the V. D. Hospital in San Juan.

Lieut.-Col. J. Encarnacion and Capt. Federico Reyes, M. C., were incarcerated by the Japanese Marines from February 9 to 18 inclusive in the Manila Hotel, and they were able to escape only when the hotel caught fire in the afternoon of February 18, 1945.
