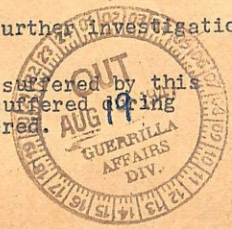

Dear Lieutenant Nuqui:

The Commanding General has directed that you be informed that the 3rd Battalion, Provisional Regiment, Philippine Scouts, consisting of Headquarters and Headquarters Company, Company I, and Company M, a guerrilla unit under your nominal control, recognized by letter Headquarters USAFFE, dated 1 June 1945, has not been favorably considered for revision of its present recognition date.

A careful analysis of all available information of the military activities of your unit from its inception, scrutinized in relation to the overall resistance movement, has failed to justify sufficiently the establishment of a date of recognition other than that presently published.

This letter constitutes the final determination of and action upon the period of official recognition of the 3rd Battalion, Provisional Regiment, Philippine Scouts.

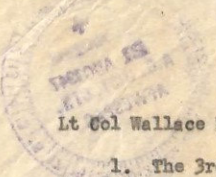

Report on Revision of the 3rd Bn, Provisional Regiment
Philippine Scouts, consisting of Hq and Hq Co, Co "I"
and Co "K"

1. During the period 17 July - 22 July 47, 1st Lt Marion C. Allbright made an extensive search in an attempt to locate any documents concerning the history and recognition of the 3rd Bn, Provisional Regt, Philippine Scouts (PRPS).

2. There is no unit history for this unit. The unit was, according to correspondence on file with Guerrilla Affairs Section, HAP, ordered to submit its rosters for recognition by G-1 XI Corps. It was recognized by letter, Hq, USAFFE, dated 1 June 45.

3. FINDINGS:

During the course of the search for any information concerning this unit, one Capt M. S. Fajardo, PA, visited this office with regard to his services as a guerrilla with the 320th Sqdn, a unit under the overall command of Major Lapham. Fajardo was recognized as a guerrilla member of the 3rd Bn, PRPS. Among the documents in his possession was an original order signed by Lt Col Edgar Wright, Jr, ordering all Philippine Scouts to report for duty by the 20th of January 1945. According to Fajardo, Wright was the organizer and overall commander. A true copy of this order by Lt Col Wright is attached as Tab A.

Since the reporting date was 20 Jan 45, and this unit has been recognized as of 29 Jan 45, it is reasonably assumed that during this period of nine days the unit was being organized and equipped. The members having been drawn from several organizations, according to Fajardo, there is no record of this unit previous to this date. (20 Jan 45).

The reporting date, as established by the order signed by Lt Col Wright, is conclusive proof that the unit as such did not exist before 20 Jan 45, and no evidence of any activities during the period of 20 Jan-29 Jan 45, has been found.

There are no records concerning this unit and if casualties were suffered there is no record of them.

4. POLITICAL ASPECTS:

This unit appears to have no political affiliations or aspirations.

5. RECOMMENDATIONS:

It is recommended that no revision of present recognition dates be contemplated for the 3rd Bn, Provisional

1. a. The guerrilla units listed on attached list have been recognized by the Commander-in-Chief as authorized elements of USAFFE. Under the Provisions of Executive Order No. 21, by the President of the Commonwealth of the Philippines, dated 28 October 1944, the status of members of these units, who have served while the unit was in direct support of Sixth Army combat operations, is that of officers and enlisted men of the Philippine Army.

b. At such times as additional units are recognized, you will be forwarded supplementary lists.

2. It is desired that you notify those units on the attached list that are operating under your control that they have been recognized. The rosters of such units, as required by paragraph 3, letter this headquarters, AG 384 A-2, Subject: "Recognition of Guerrilla Units", dated 25 February 1945 which have not yet been submitted will be furnished without delay.

3. It has been noted from recommendations for recognition submitted by US Army organizations that frequently individuals, or groups of 2 to 5 persons, from a large guerrilla unit are the only personnel of such unit serving with the US Army organization. In such cases the unit has not been recommended for recognition. For the payment of such individuals for their services, it is desired that they be included on the payroll of a recognized guerrilla unit serving with your command.

1. The request of Jose D. Manansala for individual non-casualty guerrilla recognition in the rank of first lieutenant as member of Squadron 320, Luzon Guerrilla Army Forces, has been investigated.
2. The request is disapproved as a member of Squadron 320, LGAF, but is approved in rank of first lieutenant as a member of the 3d Battalion, Provisional Regiment, Philippine Scouts. His period of recognition will be from 29 January 1945 to 6 June 1945, both dates inclusive.
