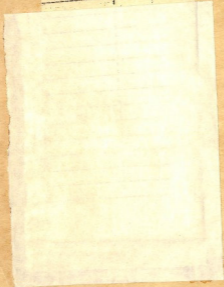

This will acknowledge receipt of your letter, dated 15 December 1947, to Major General George F. Moore, Commanding General, requesting information regarding a Palakpaquin Unit, which you claim to have commanded under the overall command of the Blue Eagle Brigade.

The Commanding General directs that you be informed that a thorough search of the files of this headquarters has failed to disclose a request for recognition of this unit. Your request, dated 15 December 1947, must therefore be considered as a new unit request for recognition which cannot be accepted for consideration as it does not comply with the closing date of 15 March 1946 which was announced by this headquarters as the final date for the submission of all unit requests for recognition.

Furthermore, perusal of your request has failed to reveal any material which would justify an exception to this announced closing date. For further information regarding this matter it is suggested that you communicate with your alleged commanding officer.

S i r:

1 Undersigned is the commanding officer of the guerrilla unit called the "Palakpaquin Unit". This unit was originally a voluntary association of the residents of Barrio Palakpaquin, City of San Pablo, created for the purpose of fighting the Japanese invaders. On May 15, 1943 we affiliated ourselves to the PRESIDENT QUEZON'S OWN GUERRILLAS.

2 During the liberation of our area, Col. Eduardo Alabastro, who was personally with us enticed our unit to sever our connections with the PQOG and affiliate ourselves with the BLUE EAGLE BRIGADE (Bicol Brigade). We accordingly submitted to Col. Alabastro our rosters and unit history and waited. And we have been patiently waiting until now. *Resubmitted*

3 Recently, the undersigned personally went to the Guerrilla Affairs Division, to inquire what happened to our unit, and we were informed that our roster was not even submitted there.

4 The purpose of this letter is to inquire what other remedy, if any, is open to our unit in order to be able to present our claim for recognition in view of the expiration of the deadline for those matters.

5 We understand that all this is the result of our misplaced trust in the Blue Eagle command, but we felt we have been unjustly deprived of the opportunity to present our case to the U.S. Army authorities who are here to fulfill the magnanimous gratitude of the American people for our loyalty to the common cause.
