Sir:

- Undersigned is the commanding officer of the guerrilla unit called the "Palakpaquin Unit". This unit was originally a voluntary association of the residents of Barrio Palakpaquin, Gity of San Fablo, created for the purpose of fighting the Japanese invaders. On May 15,1943 we affiliated curselves to the PRESIDENT QUEZON'S OWN GUERRILLAS.
- During the liberation of our area, Col. Eduardo Alabastro, who was personally with us enticed our unit to sever our connections with the FQOG and affiliate ourselves with the BLUE EAGLE BRIGADE (Bicol Brigade). We accordingly submitted to Col. Calabastrojour rosters and unit history and waited. And we have been patiently waiting until now.
- Recently, the undersigned personally went to the Guerrilla Affairs Division, to inquire what happened to our unit, and we were informed that our roster was not even submitted there.
- The purpose of this letter is to inquire what other remedy, if any, is open to our unit in order to be able to present our claim for recognition in view of the expiration of the deadline for those matters.
- We understand that all this is the result of our misplaced trust in the Blue Eagle command, but we felt we have been unjustly deprived of the opportunity to present our case to the U.S. Army authorities who are here to fulfill the magnanianus gratitude of the American people for our loyelty to the common autus.
