The Base Hospital No I was ordered to function actively on Jan 12, 1945 at Bustos, Bulacan supporting the 1st Regiment and 9th Pencil Regiment, treating their casualties (after minor encounters with the Japanese) at the provisional building at Bustos. Then it was ordered to proceed to Makinjan in the mountains. After staying eight (8) days there it was transferred to Sr. Rafael to support the division. From Sr. Rafael it was ultimately transferred to Bustos where it work in conjunction with the 112th Cavalry division under Brig. General Cunningham. In this location casualties suffered by the guerrillas fighting in Angat and Rodriguez as well as in Bustos and Belingue are brought to said Hospital. After the 112th Cavalry was transferred to St. Maria we worked with the Wilson's Troop under the command of Capt. William Stallinge. To support the above units until March of this year.
