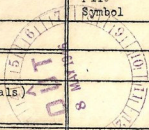

Dear Mr. Luzana:

X Your letter dated 3 February 1946 relative to the activities of the Civilian Scouts, Antipolo, Camarines Sur, addressed to the United States High Commissioner has been referred to this headquarters for consideration.

The information relative to the personnel and activities of the organization under your nominal control indicates that the members of the unit were not actually maintained in the field nor did they devote their entire efforts to military activity to the exclusion of normal civilian pursuits.

In view of the foregoing recognition of the Civilian Scouts, Antipolo, Camarines Sur, does not appear to be warranted. However, if documentary evidence of the guerrilla activities of this unit is available, this evidence may be submitted and will receive due consideration.

- (a). We supplied them, Carabaos, Cows, pigs, chickens, eggs, bananas, and all kinds of growing crops.
- (b). We supplied them rice, through man power.
- (c). We supplied them boats and carabaos for their transportation
- (d). We transported the supplies to their Camps.
- (e). We were the runners.
- (f). We were the carriers.
- (g). We were the spys, day and night service as (Randa).
- (h). We guided them where the japs are station.

For this reason, I have the honor to request from your honorable attention, if said groups is intitled for pay.

For further information, the 82nd. Division Field Artillery. Headed by Lt. Capt. Taylor had recognized my services.

At present I am now employed Provincial Guard of Naga, Camarines, Sur.
