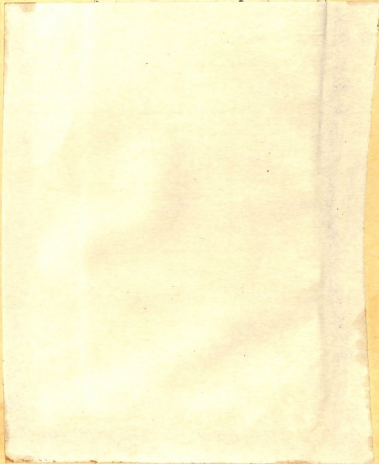

Dear Mr. Dayao:

This will acknowledge receipt of your letter, dated 29 June 1947, requesting recognition of a guerrilla intelligence unit under the command of Captain William C. Younger, referred to me for reply by Major General George P. Moore, Commanding General.

A special press release from Headquarters AFWESPAC, dated 1 February 1946, announced the closing date for acceptance of unit requests for recognition as 15 March 1946. Your request, dated 29 June 1947, does not comply with this closing date and cannot, therefore, be accepted. It is considered that all concerned have had ample opportunity to prepare and submit unit requests prior to the announced closing date.

For your information, the date 31 July 1947 to which you refer was the closing date for acceptance of casualty claims. The final date for acceptance of individual non-casualty claims was 15 March 1947.

However, you are presently included in the roster of the Manila Intelligence Composite Unit, Anderson's Guerrillas, currently pending action by this headquarters. For further information of your status therein, it is suggested that you communicate with your commanding officer, Armando Flores, who will be informed of the action taken at the earliest practicable date.

The roster and papers submitted with your letter of 29 June 1947 are returned herewith.


