Dear Mr. de Sagun:

This will acknowledge receipt of your letter, dated 20 February 1948, requesting recognition of the Milar Bolo Regiment under your command and forwarding a roster and records of the unit.

A thorough search of the files of this headquarters has failed to reveal a request for recognition of a claimant guerrilla unit listed under the name of the Milar Bolo Regiment. It is desired to inform you that a special press release from the Public Relations Office, Headquarters, AFWESPAC, dated 1 February 1946, announced the closing date of 15 March 1946 for the acceptance by this headquarters of unit applications for recognition. Inasmuch as this closing date received wide dissemination throughout the Philippines by press, radio and municipal agencies, it is considered that all concerned had ample opportunity to prepare and submit unit applications prior to the announced closing date. Inasmuch as your request for recognition of your unit was made in your letter of 20 February 1948, it does not comply with the closing date of 15 March 1946 and therefore cannot be accepted.
