Dear Mr. Aldana:

The Commanding General has directed that you be informed that the "Pugot Ulo" Secret Society Cut Head, purporting to be a guerrilla organization under your nominal control, is not favorably considered for recognition as an element of the Philippine Army.

A set of general requirements for guerrilla recognition, established by General MacArthur during the liberation of the Philippines, has been used as a guide in considering the record of this unit. After careful investigation and full consideration of all substantiating records and testimony of witnesses having pertinent knowledge, recognition of this guerrilla unit is not deemed to be warranted because of reasons mentioned below:

- a. Record of service was not substantiated by sufficient acceptable evidence.
- b. The unit was not maintained satisfactorily in the field in opposition to the enemy.
- c. Activities of the unit did not contribute materially to the eventual defeat of the enemy.
- d. A definite organization was not established.
- e. Adequate records were not maintained (names, ranks, dates of enlistment or joining, dates of promotions, and necessary related information).

It is requested that you comply with the provisions of Executive Order No. 68, by the President of the Philippines, dated 26 September 1945, copy attached.

REPORT ON "PUGOT ULO SECRET SOCIETY CUT HEAD"

1. REQUEST FOR RECOGNITION RECEIVED ON 15 JAN '46.

2. ALLEGED HISTORY: (See Attached Unit File).

3. FINDINGS:

- a. Record of service was not substantiated by sufficient acceptable evidence.
- b. Unit was not maintained satisfactorily in the field as the members lived at home and carried on their civilian occupations.
- c. Activities of the unit did not contribute materially to the eventual defeat of the enemy for the units main activity *was* *the spreading of* propaganda.
- d. Adequate records as to ranks, dates of enlistment and promotions and necessary related information were not maintained.
- e. A definite organization was not established for no T/O was set up. Members were just listed by their names. A complaint letter in our office states this unit was just a political club and not a guerrilla organization. (See letter attached in unit file.)

4. POLITICAL ASPECTS:

The organization evidently has political leanings, but party affiliations are not known.

5. RECOMMENDATIONS:

It is recommended that the Pugot Ulo Secret Society Cut Head be not favorably considered for recognition. No useful purpose will be gained by further investigation of this unit as there are no worthy members and there were no casualties.

SUBJECT: Request for Recognition.

TO : Commanding General, AFWESPAC.
(Thru: Channels)

1. Immediately after the fall of Manila under the Japanese Forces, a secret and subversive society known as "Pugot Ulo", Secret Society Cut Head was organized on 2 February, 1942, in the Municipality of Las Pinas, Province of Rizal.

2. The purpose of the society was to receive war news thru Short Waves coming from the FILAMERICANS at Bataan and latter at Corrigidor. After the fall of Corrigidor war news were received from Australia and San Francisco. The news received are spread and rebroadcasted to the town people, to the American war prisoners working in the Las Pinas Airfield and to the people of neighboring towns in order to beat or destroy false Japanese war propagandas and to bolster up the morale and faith of the people until the return of the American Liberation Forces.

3. One of our stations was raided by the Japanese Military Police and the Vice President of the Organization was apprehended, tortured and imprisoned for 19 days in Fort Santiago, but he was released for lack of evidence and for refusing to admit his guilt. However the Radio and other Paraphernalias of the station was never returned.

4. The Recognition of the above mentioned society as a MILITANT ORGANIZATION working in close collaboration and cooperation with the Guerrillas during those hectic days of Japanese occupation is highly requested by its members.

AFFIDAVIT

That I, Venancio Oliva, of legal age, single, Filipino and resident of the municipality of Las Piñas, province of Rizal, Philippines, after having been duly sworn on oath, hereby declare, depose and say:

1. That I am the Vice-President of the so-called Kapisanang "Pugot Ulo" (Secret Society Cut Head) of Las Piñas, Rizal, Philippines, which was organized in Las Piñas, Rizal, Philippines, in February, 1942, by some of its residents, the purpose of which was to get from the short waves the news broadcasted from a broad by the Allied Nations specially from San Francisco, California, U. S. A. regarding the progress of the war specially in the Pacific area and spread the same to the people of the town of Las Piñas, Rizal, Philippines, the neighboring towns, to the members of the guerillas, to the American War Prisoners concentrated in the Las Piñas Air field of the Japanese Navy, etc., to rebut and destroy the false propoganda of the Japanese published in their local newspapers, magazines, etc. and keep the morale of the people in favor of the Allies.
2. That I was the owner of the radio we were using in securing news from abroad and we distributed these news to the members of our society in our Headquarters. My radio is located in my house. Our headquarters is only in front of my house.
3. That on the midnight of March 16, 1943, my house was raided by the Japanese Military Police and we were fortunate enough because we did not take news at that evening, however, I was arrested by them (Japanese) and my radio and antennae were taken.
4. That I was ~~then~~ detained in the Japanese Military Garrison at Baclaran, Parañaque, Rizal, where I was heavily guarded and tortured almost to death as they were forcing me to admit that we have a secret society in our town whose members were taking news from the short waves and that the radio which we were using was mine. As there is no evidence in the charges preferred against me I denied it.
5. That after three nights and two days detention in Baclaran Japanese Military Garrison, they transferred me to Fort Santiago, where I was also tortured very much to force me again that our secret society was sabotaging the Japanese government, which I did not also admit. During my detention in Baclaran, I was not given food to eat nor water to drink.
6. That on March 25, 1943, after they could not get anything from me, as I did not admit anything in spite of all punishments they gave me, they released me very weak and sickly for which I was forced to submit to medical treatment and massages.
7. That my radio and antennae were confiscated by the Japanese at Fort Santiago, Manila, where I left them.
8. That in order to continue our sabotage work against the Japanese administration we secured the radio of our co-members of the society to get news from abroad until after the liberation of our town.

IN TESTIMONY WHEREOF, I have hereunto set my hand in the municipality of Las Piñas, province of Rizal, Philippines, this 12th day of January, 1946.
