Dear Mr. Zamora:

The Commanding General has directed that you be informed that the 12th Infantry Regiment, Castaneda Unit, purporting to be a guerrilla organization under your nominal control, has not been favorably considered for recognition.

It is felt that the number of men recognized with the Fil-American Cavite Guerrilla Forces (FACGF) under the overall command of General M. N. Castaneda, constitutes a just and adequate acknowledgement of the military services performed by the Fil-American Cavite Guerrilla Forces.

It is desired to emphasize that each claimant member of the unit is considered to have had just and adequate appraisal for recognition when his services were evaluated concurrently with this study of the unit with which he claims membership. Individual requests were not necessary nor appropriate then, or now, as their acceptance would in effect constitute unjustified duplication of consideration of one individual by this headquarters. However, this does not preclude submission for casualty recognition by those individuals who are qualified and feel justified in entering such claims. Upon request by interested individuals, appropriate forms will be forwarded.

Your attention is invited to Presidential Executive Order No. 68, Commonwealth of the Philippines, copy of which is attached, for any necessary action in connection therewith.

Report on 12th Infantry Regiment, Castaneda
Unit, Fil-American Cavite Guerrilla Forces (FACGF)

1. On 17 April 1947 Lt Lester W Pierce Jr examined the files on the 12th Infantry Regiment, Castaneda Unit, FACGF.

2. ALLEGED HISTORY: (See attached unit file)

3. FINDINGS:

a. This unit is a part of the FACGF under the overall command of Gen. M. N. Castaneda. The FACGF was investigated in May 1946 by Lts Peter R. Betts and Tiroso Cura and a recommendation was made that the command be not favorably considered. (See Team Leader's Report by Lt Peter R. Betts attached).

b. This unit was originally organized as a home guard unit to protect the town from lawless elements running wild in Cavite. There is no documentary evidence that the unit had any activities either before or during the Liberation. The only claims of activity by the unit are that an American pilot who crashed on 4 January 1945 in Kaybal, Amadeo, Cavite was given aid and turned over to Maj Vanderpool and that the unit helped to collect supplies dropped on Tagaytay Ridge by the 11th AIB Div. There is nothing to show that the unit materially contributed to the eventual defeat of the enemy.

4. POLITICAL ASPECTS: This unit does not appear to have any political affiliations or aspirations.

5. RECOMMENDATIONS: It is recommended that the 12th Infantry Regiment, Castaneda Unit, FACGF, be not favorably considered for recognition.

REPORT ON "CASTANEDA UNIT FIL-AMERICAN
CAVITE GUERRILLA FORCES"

APO 707

In accordance with verbal orders from Chief of Branch, Guerrilla Affairs, G-3, AFWESPAC, Lletutenants Peter R. Betts and Tirso Cura proceeded to Imus, Cavite, to contact the "Castaneda Unit Fil-American Cavite, Guerrilla Forces," in order to determine whether or not this organization should be recognized by the United States Army. The following report is a summary of the investigation and basis for the recommendation.

HISTORY

In October of 1942 Col Mariano N. Castaneda claims to have organized the Castaneda Unit FACGF under orders from General Manuel Roxas.

I wish to state now that all the above has been claimed and in the findings will be proven false.

FINDINGS

Upon investigating the Castaneda Unit Fil-American Cavite Guerrilla Forces it was found that, although Col Castaneda claims to have organized his unit in 1942, this unit was unknown to other guerrilla forces operating in the same area until 1944. Many of those regiments under Castaneda were in existence before 1944, but purely to protect their towns from the lawless elements running wild in Cavite. Among the units claimed by Castaneda, are known bendits, Ceruncong's Regt and Saulog's Regt were stated to have been bendits. Col Terry Adeveso, Commander of Hunter's ROTC Unit in Cavite

said he fought Saugog and suppressed his unit. Many men in Castaneda's unit have been called collaborators by members of other units in Cavite, swear that the major of Silang, Col Kiamzon, commander of Kiamzon's Regt. secured foodstuffs on the pretence of giving them to his guerrillas, but gave them to the Japanese. We have complaint letters in our office naming certain men in Castaneda's Division Headquarters as bandits and collaborators. These letters have been substantiated by Capt Sendico P.S., Col Terry Adevoce, and Col Quintin Gallidon P.A. There are no records of any activities, before November and December of 1944. When asked to show records of their activities, the Regt. commanders all said they had to destroy them or it was unsafe to make any. In August of 1944 Col Castaneda was made acting Governor of Cavite and then and only then did he organize these separate home guard units into the Castaneda Unit FACGF. In one of the regimental histories it states that Castaneda issued a proclamation to incorporate these individual units under one head in the late fall of 1944. The time between the incorporation of these units and when the Americans landed was spent in training and organization. After receiving a week or more of training the men returned to their homes to carry on their labors along with supplying information concerning Jap movements in that area.

The members of the unit worked only part time. Col Castaneda states that during the liberation he lost contact with two Regts. This certainly shows poor control. Many members of this unit served with the 11th Airborne during the liberation and have been processed and paid for their services. But before the liberation this unit did not materially contribute to the defeat of the enemy.

POLITICAL ASPECTS

This unit has very definite political aspirations. Many of the Regimental Commanders were acting mayors of their respective towns. Col Castaneda is one of Manuel Roxas' fervent supporters and did all in his power to gain every vote in Cavite for Roxas and will get one of the top positions in the Army because of it. He expects to be made MP Commander of the whole Philippines Army Provost Marshall General, or Chief of Staff, P.A.

RECOMMENDATION

After careful considerations of the statements made by present members of the organization and outside sources it is recommended that the Castaneda Unit Fil-American Cavite Guerrilla Forces be not favorably considered for recognition.

H I S T O R Y

The 12th Infantry Regiment was originally composed of USAFFE, farmers, local merchants, and Ex-Mayor Carlos Batino, of Tagaytay City.

CAPTAIN JESUS O. ZAMORA, USAFFE, before the outbreak of the war, was under COLONEL MARIANO N. CASTANEDA, as Junior Officer, of the 1st Regular Division, Camp Murphy. During my stay at Imus, Cavite, I met again COLONEL CASTANEDA, and informed me about his underground organization.

Conferences with COLONEL MARIANO N. CASTANEDA, USAFFE, were held in his private office at Imus, Cavite and as well as in Manila, to discuss ways and means to organize a guerrilla outfit at Amadeo, Tagaytay, attached to his main group.

As the Ex-Mayor of Tagaytay City, was my uncle, sufficient volunteers to join our outfit as a nucleus for the proposed Tagaytay Unit, under the over-all command of COLONEL CASTANEDA.

Our first conference was held at the residence of Ex-Mayor Carlos Batino, at Tagaytay City. As a result of this conference the following plans were approved:

- (a) To organize separate units as members of the 12th Infantry Regiment, small in numbers for strategy and mobility as all guerrilla units should be.
- (b) To establish a Headquarters, somewhere in the fields of Amadeo, for the purpose of secret and temporary coordinating the field work and other guerrilla activities.
- (c) To contact all USAFFE, especially the escaped USAFFE, within the Amadeo sector.
- (d) To make actual reports of the ins and outs of Japanese Troops stationed at Tagaytay City, or render a systematic Intelligence Service for the use of SWPA thru GHQ, PACGF (CASTANEDA'S UNIT.)

As an open opposition to the Japanese Army would have been fruitless until arms were brought in sufficient numbers, we never attacked Japanese Units in the field. Restriction against the civilian population would have followed as the actively occurred in different localities. Some of our small arms (pistols) were hand-made or home made. Despite the risks involved the underground campaign for liberation met instant popular approval and later than a month a company was formed with some arms and bolos. Other units were subsequently organized.

The historic events for this unit started on January 4, 1946, when an American pilot of a P-38, 1ST LT JOHN E. PURDY, AC, USA, crashed-landed in Kaybal, a barrio of Amadeo, Cavite.

CAPTAIN JESUS O. ZAMORA, (USAFFE), with Ex-Major Carlos Batino, of Tagaytay City, and some guerrilla members rushed to the rescue of the said pilot. LT JOHN E. PURDY, was taken to safety. Medical treatment was given by Dr. Bibiano Ankaw, of Amadeo. Immediately after the American pilot crashed in the said barrio, the Japanese Garrison at Tagaytay City, issued a proclamation of death for anyone who may saved the life of the American pilot, and a reward was offered for the finder. A house to house search was made by the Japanese Army, with the aid of the Makapilis, but despite of odds and difficulties we were able to bring the American pilot to safety. After several weeks LT JOHN E. PURDY, was taken to Mindoro, by MAJOR JAY VANDERPOOL, GSC, GHQ, MWP.


On February 4, 1945, I met again MAJOR JAY VANDERPOOL, at the Manila Hotel (Taal Vista Lodge), Tagaytay City. He instructed me to collect all the supplies to be dropped by the 11th Airborne. On that day arms, amunitions, and food supplies were dropped by planes. Our unit helped and inspite of all odds and serious difficulties we succeeded within our best means.

The following day, MAJOR JAY VANDERPOOL, told me that arms and amunitions will be given to our unit at Nagsubu, Batangas. I went there personally but instead we are notified to draw at Tagaytay City. Hand grenades were issued to our unit.

With the 11th Airborne Division, stationed at Tagaytay City, we worked close with the Guerrilla Affairs and with the Civilian Affairs under MAJOR CHUTECHFIELD, SIGC, USA.

And the day came when all was clear. On that day COLONEL MARIANO N. CASTANEDA, USAFFE, issued Memorandum of demobilization to all units, after submitting to MAJOR GENERAL JOSEPH M. SWING, CG, 11th Airborne Division, USA, and to MAJOR JAY VANDERPOOL a report, which included the Roster of our 12th Infantry Regiment.

As Executive Officer, of the 12th Infantry Regiment, Fil-American Cavite Guerrilla Forces, I was in continuous contact with GHQ, FAGCF. I contacted there and made reports to COLONEL MARIANO N. CASTANEDA, CO, of FAGCF, COLONEL JAVALERA, Chief of Staff, LT-COLONEL PRIMITIVO RAMIREZ, The Adjutant General, and LT-COLONEL MANUEL LIM, Staff Judge Advocate and Adviser to the CO, on legal and civil matters. I was even offered a position in the Editorial Staff of PALTIK, official organ of FAGCF, but my Regimental CO disapproved my transfer to GHQ, FAGCF.
