The recent press release from Public Relations Office, PHILEYCOM, further announced the closing date of 15 March 1947 for the submission of individual claims for non-casualty recognition.

It is considered that all concerned had ample opportunity to prepare unit applications for recognition by 15 Waren 1946. Your request for recognition of the Women's Auxiliary Service, Agoho Sector, Mambajac, under the 110th Infantry Regiment 110th Infantry Division, Tenth Military District made in your letter, dated 26 November 1946, to the Commanding Officer, Tenth Wilitary District, and forwarded through military channels to this headquarters does not comply with the closing date and therefore cannot be accepted for consideration.

This decision does not preclude submission of claims for easualty recognition by these individuals who are qualified and feel justified in entering such claims. Upon request from interested individuals, appropriate forms will be forwarded.


