

- 3. The Overell strength of the EOLGA as of 15 May was eproximately 35 officers end 395 EM; as of 31 September 1922 was approximately 215 officers end 2,182 EM; as of 31 Bosember 1922 was approximately 863 officers and 7,006 EM; as of 30 June 1923 was approximately 1,241 officers end 10,512 EM; as of 30 June 1923 was approximately 1,240 officers end 21,832 EM; as of 30 June 1942 was approximately 2,006 officers end 28,822 EM; as of 31 Ducember 1944 was approximately 3,606 officers and 38,624 EM; as of 31 June 1945 was approximately 3,606 officers and 38,500 EM. The above figures include occupates. Strength indicated, by official rosters of Headquarters Philippine Army as approved by Headquarters, EMFFE, Headquarters, 6th Army, and Headquarters, ANWESPAG, with the period of service of the individuals not to commonce prior to their dates of inductions as shown on the individual reprocessing 201 files in the possession of the Recovered Personnel Division, APO, FWESPAG, will not be exceeded in determining personnel entitled to pay. Overall strengths mentioned ebove indicate maximum figures that will not be exceeded.
- 4. No commissioned renks above that of Captain are authorized prior to 1 Jenuary 1944 with the exception of those US/FFE officers in the rank of captain and above, who were given original appointments with an increase of one grade above their ormy ranks. Subsequent to 1 Jenuary 1944 ranks of officers, commonneurs with their command or staff functions and beacd upon the tables of organization of a US Infantry Division, less one grade, are authorized.
- a. Recognition as mentioned in peragraph 1, above, is limited to payments of those units listed that served on the Island of Luzon with the ECLGA.
- b. All civilians recruited by or inducted into the ECIGA subsequent to 15 May 1942 are considered to have become members of the Philippine Army, served with the Armod Forces of the United States with entitlement to pey subsequent to that date.
- 6. The East Centrel Lugon Guerrills free has nover printed any script for its operational expenditures, depending almost entirely upon denotions in kind from the civilian population for sustanence. No personnel, either offieer or enlisted, received any pey from the time of its inception on 15 May 1942, until the recognition of those units of EDICA by Attachment, Personnel
