

b. Casualties have been clearly emphasised in subpar., b, of mentioned basic letter, but due to clerical error same can not be found on inclosed roster of unit already submitted.

o. Personnel of this unit have also been actually an actively stached to all units mentioned in subpar., b, of mentioned basic letter entitled "Request for Recognition", dated January 21, 1966 with medical bast of their designation with us to the 71st and 78th Paraution Hospital.

2. The following is the important activities of SABO* TAGE UNIT, which has been accomplished to my full satisfaction:

a. Nov. 12, 1942 Japs food stuff bound from Manila to Dagupan was thrown overboard the train, and was taken for use of my unit.

b. Dec. 27, 1942 gasoline at railroad station was and has been by them spilled and have killed two Japs guard.

c. Mar. 10, 1943 a Japs cotton inspector on an inspection tour riding a bicycle was kidnaped and killed by same at Ballbago, Tarlac.

d. May 20, 1944 Japs Bodega was raided and coconut oil taken by SABOTAGE UNIT who in turn distributed it to civilians.

e. Jan. 9, 1945 train carrying guns and ammunition from San Jose was derailed at San Jacinto, Victoria, Tarlac; and Japs retreated to secure aid.

 Jan. 17, and 18, 1945 telephone lines running to all direction of their command were cut and destpoyed.



At as early as 18 January 1945 my unit was ordered to proceed to Tarlas, to meet and guide the Liberation Forces; and in Tarlas proper, (espital of the province), or or about 22, January, 1945, we encountered the last Japs garrisên; numberé to about (50), and we were able to drive them up in the hills nearby.

b. On 24 January, 1945 we were first stached to 71st Evroution Hospital, under the commit of Dol. Grenade up to 30 January 1945; and from January, 1945 to March, 1945; attached to 98th Evroustion Hospital under the command of Colonel Banker; and again from March, 1945; to the early part of Mary, 1945, attached to 335rd Signal Corpe, and from them on up to 14 July, 1945, we were actively attached to the 26th Signal Corpe; and during all these period of attached, we encounter lost no opportunity in getting all of thes; in Mache attached roster of unit.

c. The 2cth Signal Corps was ordered to moved to Pataan, and we further served to then in the same capacity, as security guards, patrol and Military Police duties up to the tide when ny unit was released from attachment on 14, July, Jufs, that was when above mentioned U S ARMF unit was ordered to moved again to OKI-NAWA.

d. When my unit was relieved from attachment our H0, 6th Regt. HBD, was already disolved, (dispediation of mane was effective 7 June, 1945), without having instructions recieved either from US ARMY units at the time, I had no way of knowing what to do, except to establish our temporary HM, for sometime in Farlace

> and in Forac, Fampanga, waiting for the result of our services rendered to all US ARMY units above mentioned; I have inquired after sometime from all available Headquarters and to EFA as to wether my men appear in the recognized roster; in as much as it was our belief that having been attached actively to US ARMY units we are authomstically recognized.

e, It was not until very recently when our names do not appear in any recognized rooter did we understand that we have been abundonsd; after I inquired further as to what action whill I take to insure the status of my unit, did I only come to know that if was required of an abandoned querrills unit to submit a request for recognizion before it shall be considered recomined and set wid.

 In view of the foregoing it is believed that immediate and full consideration to subject officers and enlisted men shall be acted upon.
