



3. Name of over-all Commander: Capt. Ralph McGuire and Col. Gyles Merrill.
4. Activities Rendered: From 14 Sept. 1942 to 29 January 1945.
5. Sub-Unit: "F" Company, Santa Cruz Sector, Squad. "A"

(NOTE: on the liberation of Zambales, my Sector as stated above, which I was in continuous comand from 14th Sept 1942 to 28 January 1945, was devided into different companies starting from the 29th January 1945 when we were attached to mopping operations with American Forces by order of Maj. Ramon Magsaysay who succeeded Col. Merrill. It came that I was assigned to command one Company, the "F" Company under Squadron "A", Magsaysay Forces, as now appearing in your records as a recognized unit.)
