Report on the Botolen Sector, Squadron "B"

In secordance with verbal instructions from Chief of Section, Comertilla Affairs, G-), AFRESPAC, Mastenant Morris S. Flory proceeded to Rotlans, Zambalos to contact the Botelan Section, Magasy-say's Ferress, ZMD', in order to determine whether or not this organization should be recognised by the United States Army. The following report is a summary of the investigation and basis for the recommendation.

ALLEGED HISTORY

This unit organised in the middle of 1942 but did not function as a military unit. Members left the unit up until June 1943 when the unit was reorganised with permission of dapt. Schulre, placing Gapt. Corum as the Commanding officer with a total strength of over 400 men. From this time until the American occupation of Zembelss the unit did patrol and intelligence work, but had no encounters with the Japanese.

On 25 January 1945 they began operations in the mountains of Botolan and contested the 3rd Bn 152 Inf under Lt. Col. Mongold. On the 29 of January 1945, the unit fought the Japa in the Mountains of Botolan shigh was the first encounter with the enemy. They remained with the 152 Inf until May 1945, after which time they were used in mogning up details, security guards, and patrols for rice planters.

Capt. Corum was discharged from the unit 18 June, 1945 to take charge of civilian operations in the Betolan mountains. Capt Jose Repomment then took over control of the unit and remained as CO until his discharge from the unit at Camp Ord 31 May 1946.

The unit was composed of a Hq & Hq Co, Cos; A,B,C, & D making one Battalion with a peak strength of approximately 700 (reported) in 1945.

The unit in question has previously had the following men recognized:

Upon investigation it was found that this unit in question did only "Home Guard" duty up to the time of the American landings in Luson.

In their request for recognition they state the men on the supplementary rosters were not included in the previous supplemental rosters because they were not yet paid and that only those already paid were included. This affords no proof that these men deserve to be rewere included, this attorn no proof that above men deserve to be cognised as a part of the former initial or supplementary roster. Capt. Corum, former Commanding officer of this unit stated that the names were left off because only the names of those men actually on patrel work were submitted, that those men on the supplementary roster were on other duty such as guard, procurement of supplies, etc., but they have no papers to prove such claim.

The unit was at times at odds with the Botelan Special Regiment under Capt Battad, although the former Botolan Sector Commander, Corum and Battad are cousins.

It was also apparent in the investigation that a rotation system was used by the unit, members working one or two days a week and working on their farms the remainder of the week. It is concluded that members of this organization did not have full time status as a guerrilla, except these already recognized. It is also believed that the members of the unit worthy of recognition have been recognized with the above mentioned units.



POLITICAL ASPECTS


