3. Subject individual was inducted into said unit 1 August 1943, and left in 1945 according to signed certification by Eulogio N. Peregrino, Commanding Officer of the Unit.
4. Subject individual also submitted assigned certification by Eulogio N. Peregrino dated 1 November 1943, permitting him to move to other sectors.
5. Subject individual did not join Hekar Division until 11 February 1945, and the 1st and 3rd Regiments of Hekar Division claim subject was fighting continuously with their unit from 11 February 1945.
6. Subject individual did not account for his time from date he left Magway's unit (unknown) to 11 February 1945 when he joined Hekar Division.
7. Subject individual did not submit any induction papers for either unit.
8. Subject individual did not submit any substantiating evidence to support his claim.
