Dear Mr. Peregrino:

The Commanding General has directed that you be informed that the supplementary rosters of Company A, Squadron C, Magsaysay's Forces, ZND, and Company D, Cabangan Sector, Squadron C, Magsaysay's Forces, ZND, purporting to be a guerrilla organization under your nominal control, are not favorably considered for recognition as elements of the Philippine Army.

A set of general requirements for guerrilla recognition, established by General MacArthur during the liberation of the Philippines, has been used as a guide in considering the record of these units. After careful investigation and full consideration of all available substantiating records and testimony of witnesses having pertinent knowledge, recognition of these guerrilla units is not deemed to be warranted because of reasons mentioned below:

a. Adequate records were not maintained (names, ranks, dates of enlistment or joining, dates of promotions, and necessary related information).

b. Record of service was not substantiated by sufficient acceptable evidence.

c. Unit did not show satisfactory continuity of activity and organization.

It is considered that the previous recognition of approximately 354 officers and men from Headquarters and Headquarters Company, Companies A, B, and C, Cabangan Sector, Magsaysay's Forces, ZND which were recognized by the Commanding General, AFWSWPAC for their aid during the liberation of the Philippines constitutes adequate and just acknowledgment of military service.

It is requested that you comply with the provisions of Executive Order No. 68, by the President of the Philippines, dated 26 September 1945, copy attached.

Lt. Col. Hugh L. Carnahan:

1. The supplementary rosters of the "Cabangan Sector, Sqd C, Magsaysay's Forces, ZMD," consisting of the following companies under the command of Capt Eulogio N. Peregrino is not favorably considered for recognition.

Co A - 68 men  
Co D - 136 men

2. Basis for non-recognition:

a. Adequate records were not maintained of names, ranks, dates of enlistment or joining, dates of promotions, and necessary related info.

b. Record of service was not substantiated by sufficient acceptable evidence. Certification submitted with Co. D stated that 5 officers and 63 En supported the 152nd Inf but is specific only Cabangan Sector, giving no particular Co while there are 5 Cos that claimed attachment or have already been recognized. 354 men of Hq & Hq Co, Co's A, B, and C are the companies already recognized.

c. Most of the names appearing on Co A roster are from other sectors.

d. Certification submitted with Co. A roster refers to the already recognized Co A from this Sector, although it is different Co.

e. Members of both companies did not work on a full time basis prior to the American occupation of this territory. They say have supported the 152 Inf for a short period of time as claimed but there are no papers to prove these claims.

Report on "Cabangan Sector, Squadron "C", Zambales  
Military District." (ZMD)

In accordance with verbal instructions from Chief of Section, Guerrilla Affairs, G-3, AFWESPAC, Lieutenant Morris S. Flory, on 10 July 1946, proceeded to Cabangan, Zambales to contact the "Cabangan Sector, Squadron "C", ZMD, in order to determine whether or not this organization should be recognized by the United States Army. The following report is a summary of the investigation and basis for the recommendation.

ALLEGED HISTORY

In August 1942 the Cabangan Sector was formed with an original strength of 80 officers and EM as a part of the Manila and San Felipe Sectors. Late in August 1942, by order of Col. Thorpe and Capt. McGuire the Cabangan Sector was separated and became an independent sector under the Western Luzon Guerrilla Forces with Lt. Herminiano Peregrino of the 88th FA, USA-FPB, as GO, who was given the rank of Captain, and Lt. Eulogio H. Peregrino as Adjutant and Executive Officer. McGuire allotted the Cabangan sector an initial strength of 450 men of which 442 were enlisted as of September 30, 1942. Headquarters was first set up in Mabanglit near the Zambales Mts., but as the Japs advanced, it was moved from time to time.

In the early part of 1943, because of Jap reprisals against civilians for guerrilla activity, the GO gave orders to concentrate on Jap collaborators and spies which constituted their work up until the time of the American Landings on Luzon.

Capt. H. Peregrino was captured by the Japs on 19 April 1943 and his brother, the Executive Officer of the Sector, took control of the unit. However, after the capture of Capt. H. Peregrino, many of the members surrendered to the Japs, while some remained hidden in the mountains afraid of Jap reprisals if they surrendered. At the time of the capture of H. Peregrino, E. Peregrino was given command, in absence, for he was then in Nueva Ecija Mts with Col. Lapham's outfit; Without a leader the sector became inactive.

In June 1944, a U. S. Army pilot, Eddie Higginbottom, arrived in the Zambales Mts and, after his recovery on 1 October 1944, helped reorganize the Cabangan Sector with a total strength of 515 officers and men. This time the unit was attached to Col. Merrill's Forces, later to become known as "Magsaysay's



## Guerrilla Forces."

Capt. E. Peregrino was the CO until his capture by the Japs on 19 October 1944, at which time Capt. Faustino Capati of the "General Service Troops, Cabangan Sector," became CO of Squadron "C" and Capt. Estanislao Roquie assumed command of the Cabangan Sector.

Upon the release of Capt. E. Peregrino on 5 February 1945 by American forces, he returned to reorganize the disrupted Cabangan Sector, becoming CO of the Sector with Capt. Bernardo C. Mora of "General Service Troops" as CO of Squadron "C". This squadron comprised the Gabangan, Maloma, Santa Fe, San Narciso and San Antonio areas as units of the ZMD. On 18 May 1945 Capt. E. Peregrino again became Squadron "C" Commander with Capt. Mora and Capt. Feliciano B. Fontelera as Sector Commanders.

The Cabangan Sector, consisting of one battalion, was composed of 5 companies, Hq & Hq Co, Co's A, B, C and D with a peak strength in 1945 of approximately 500 officers and men.

The primary activity of this unit was against spies and collaborators until the arrival of American forces at which time they were engaged in guard, scout, patrolling and mopping up operations.

354 men of Hq & Hq Co, Co's A, B and C have previously been recognized from this Sector.

### FINDINGS

The following named persons are those interviewed by the Contact Team and their statements are the basis for the findings:

1. Capt. Eulogio N. Peregrino - CO, Squadron "C"
2. Antonio Angeles - Judge of Cabangan, home in Sta Cruz
3. Magdalena Solomon - Sgt, Co A, Cabangan Sector
4. Alino - Mayor of Cabangan, former Ex Off, Co D
5. A. Guzman - MPC, Iba, former resident of Cabangan
6. Lt Col Leidy - Ex Off, 14th AA Command
7. Maj. Magsaysay - CO, ZMD
8. Lt. Federico Labrador - Adjutant, Squadron "C"
9. Pedro Arabejo - Co E, Squadron "C"
10. Arturo Cabling - S/Sgt, Co D, Cabangan Sector
11. Aurora Barretto - S/Sgt, Co D, Cabangan Sector
12. Florencio Alinea - 2nd Lt, Co D, Cabangan Sector
13. Maximo Eballo - 1st Lt, Co A, Squadron "C"
14. Anastacio Borja, - S/Sgt, Co A, Squadron "C"
15. Aurora Garcia - Sgt, Co A, Squadron "C"

Upon investigation it was found that this unit up to the time of American occupation of this territory was frequently out of control due to the capture of the leaders at different times. Co A, Squadron "C", Magsaysay's Forces, pending recognition, is claimed to be different from Co A, Cabangan Sector that has already been recognized. The letter of attachment, signed by Albert F. Trude, 1st Lt, 152nd Inf, the only letter of attachment, refers to the recognized Co A, Cabangan Sector. The men on the roster are mostly from other sectors. Their claimed work was as guides to American units, working all the way from Cabangan to San Antonio. There are, however, no papers to prove these claims.

Co D, now claiming recognition, claims to have worked with the recognized Hq & Hq Co, Co's A, B and C, but were under Capati and not under Peregrino who at the time was a prisoner of the Japs. Certification states that 5 officers and 63 Em supported the 152nd Inf but it specifies only Cabangan Sector, giving no particular company while there are 5 companies that claim or have already been recognized. The Executive Officer of Co D, Alinea, now Mayor of Cabangan knew little about the activities of Co D, giving as an excuse that policies changed and referred me to Peregrino. There is no proof that Co D existed as a military unit. It is concluded that the members of this organization prior to the American occupation did not have full time status as a guerrilla, and that the members of the unit worthy of recognition have been recognized with Hq & Hq Co, Co's A, B and C of the Cabangan Sector, Squadron "C", Magsaysay's Guerrilla Forces, ZMD.

#### POLITICAL ASPECTS

This unit does not appear to have any political affiliations or aspirations.

#### RECOMMENDATIONS

After careful consideration of the statements made by the present members and an analysis of the documents presented, it is recommended that with the exception of those members previously recognized, the Cabangan Sector, Squadron "C", Magsaysay's Forces, ZMD, be not favorably considered for recognition.

With the demobilisation of recognized Guerrillas approved in the Initial Rosters of the Magsaysay's Forces USAFFE PA, we who are in the Supplementary Rosters pending recognition, until now we don't have as yet any idea regarding our status.

Being Company Commander of Co. D, Cabangan Sector, under Squadron "C", within the ZMD, Magsaysay's Forces USAFFE, I am committed to my men for any development regarding recognition of my unit. In view to this, I hereby kindly request information effecting our cases, and whatever development made, we highly regards it, the greatest of favor if we are so notified.

Capt. Eulogio N. Peregrino, C. O. Squadron "C", ZMD, Magsaysay's Forces USAFFE PA, who was just recently demobilized, when asked about our recognition, says - he is not in a position to commit, only he says - he had long submitted our Roster for recognition together with necessary certification of attachment from American Unit we supported operation during the Liberation Campaign, so he further says, it would be advisable to find it out.

After the official surrender of Japan, for lack of accommodations, equipments, quarters and rations we were left as home guards. Our outfit, or rather say, those in the Initial Rosters were moved and incamped at San Marcelino Airstrip which later, they were transferred again at Camp Porac, Pampanga. For failure to receive order to report, most of us left to find means of livelihood, and as for myself, when offered the position of Mayorship of this town, I accepted appointment which position I am at present holding.
