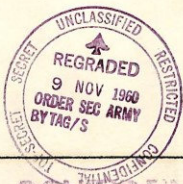





1. We are here to certify that Sgt Rodrigo Pablo Lim has been with the 38th Div. through the Campaign of Luzon. On February 3, 1945 he joined Co. G, 152nd Inf. under the Command of Capt Featherston. Then volunteered to be the 1st scout, and lead the company, which was to clear Zigzag Pass. After 16 days of stubborn resistance we cleared the Pass. Then moved to Botolan Zambales Province. There our job was to go through the Capas Trail and join the 143rd Inf. of the 43rd Div. After 15 days of fighting we contacted the 143rd Inf. We were then pulled back for a few days rest. Major Brewer of Hdqs. Co. 2nd Bn, 152nd Inf., asked him to remain with Hdqs. Co. C.P. He remained with Hdqs. Co. until April 25, 1945, he then joined Co. E 152nd Inf. We then moved to Marikina to relieve the 1st Inf. of the 6th Div. Our job there was to crack the Shimho Lines, and to clear the Japs out of the Sierra Madre Mountains, which was one of the toughest battles of the Luzon campaign. While acting as first scout on a patrol at the base of Mt. Punio, which was our objective, he was wounded by Jap machine gun fire. Thus on June 19th he entered the 17th Station Hospital. After spending 15 days in the hospital, he deserted them and went back to join Co. E 152nd Inf. During his presence in the hospital Co. E moved to Malolos, and took over bridge positions, this is where he rejoined the company. On July 10, 1945 the company was moved to Porac, Pampanga. There he again acted as first scout on patrols. He remained with Co. E 152nd Inf. until October when the 38th Division went back to the states. After the 38th Div. left he joined Co. E, 343rd Inf. the 86th Division which is his present unit.
