1. If not in conflict with the policy of the Commanding General, it is recommended that "C" Company, San Narciso Sector, Squadron "C", Zambales Military District be given official recognition.

2. This guerrilla unit has been of the utmost assistance to the Amphibious Training Center during the past two weeks in reconnoitering and assisting in clearing natives from a prospective impact area located in the Province of ZAMBALES.
