Subject unit, it is stated, was verbally ordered to proceed to Camp Ord where they were demobilized by PA Demobilization Team #6 as per SO #53 dtd 24 May 46 EDCMR 25 May 46, but were not given order to draw their salaries and allowances from any RA Finance Officer. - wd Ind by Hq 86th Inf Div, dtd 4 June 46, requests clarification of status of subj unit. Investigation by 86th Div discloses that subj unit was recognized by AFPAC on 9 Oct 45 as a supplement to Co B, San Marcelino Sector, Squadron D, Magsaysay's Forces, ZMD, with date of recognition as of 1 June 45. On 28 Feb 46 the det joined its parent organization, ZMD, already demobilized as of 31 Jan 1946, for processing and demobilization. Det was paid to include 28 Feb 46, when the det moved to Camp Ord for final processing, and discharged per SO 53, dtd 24 May 46, and SO 56, dtd 27 May 46, PA Demobilization Team No. 6, no pay was tendered at that time.

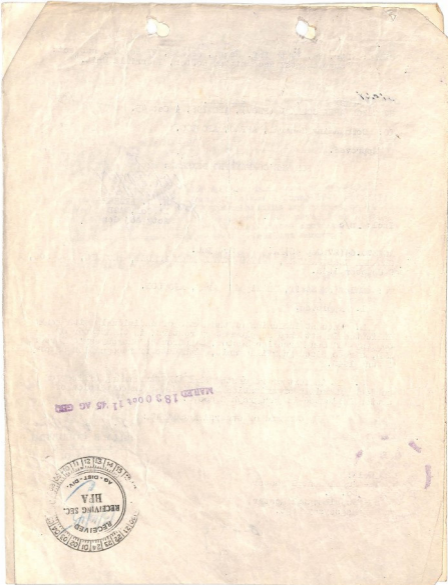

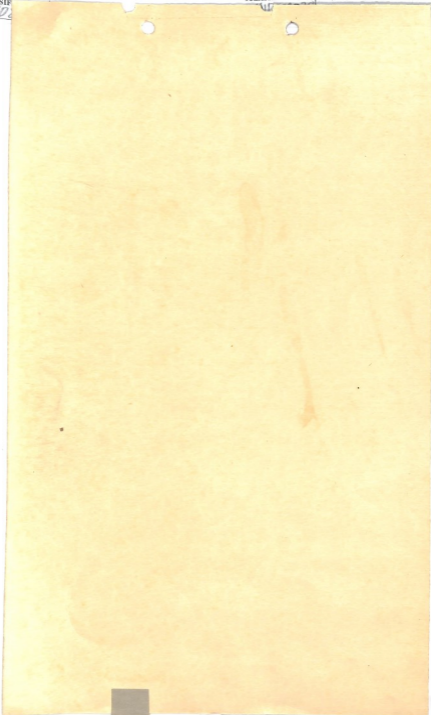

- Co "B", 2nd Detachment San Marcelino Sector, Magsaysay's Forces.
- Co "B", San Marcelino Sector, ZMD, Magsaysay's Guerrillas, (Marikina Detachment).
- Co "B", San Marcelino Sector, Squadron D, Magsaysay's Forces, ZMD.

3. Company "B" was recognized on or about 4 February 1945, with no terminal date in the strength of 50 Officers and Enlisted Men. Neither the letter of recognition nor the rosters are available in the Guerrilla Affairs Branch. Supplementary roster, Company "B", was recognized by AFPAC letter, dated 9 October 1945, with an initial date of recognition 1 June 1945 and with no terminal date. This letter had no strength and the rosters of this unit are not available in the Guerrilla Affairs Branch.

4. A roster located in the Returns Division, Headquarters Philippine Army, lists 2 Officers and 40 Enlisted Men as being members of Company "B", but the heading of the roster does not indicate whether or not this is a supplementary roster nor, for that matter, a roster belonging to "B" Company. However, attachment papers very clearly indicate the existence of a unit of 2 Officers and 40 Enlisted Men under the name of "B" Company. This branch therefore, assumes in view of the lack of other substantiating evidence, that these 2 officers and 40 Enlisted men belong to the supplementary roster of "B" Company.
