1. It is requested that the attached roster of the 1st Co., 1st En., Botolan Special Regiment, Zambales Military District, Magsaysay's Guerrillas, be approved, for the following reasons:

a. An examination of the roster of the Botolan Special Regiment now on file in the Returns Division, AGO, HPA, APO 501, reveal that the roster attached is never received in said Office. The undersigned has no way of knowing whether it was approved by higher headquarters or not.

b. A copy of this roster was filed with the District Commander's Office, Zambales Military District, Magsaysay's Guerrillas, on 19 June 1945, but evidently no action was done by that Office upon receipt of same.

c. The 1st Co., 1st En., Botolan Special Regiment, was recognized by the U.S. High Command on 25 February 1945, after having supported the operations of the 3rd En., 152 nd Inf. 38th Div. USA.

d. The personnel of this Unit were all processed in Camp Murphy, 3rd Replacement Battalion, APO 75, on orders from the XI Corps, USA. All the officers of said company are now activated with the different PA units and all the enlisted men are likewise activated.

e. The undersigned was designated Acting CO of this company in addition to his duties as Regimental Judge Advocate on 1 June 1945 and was processed with this unit as stated above.






