1. Sgt. P. N. Trocio, 1st Ron Bn, now on T.D. with Company D, 597th Sig. A. W. Bn, Mindoro, arrived this Headquarters 28 February to obtain pay and supplies. Reported the following:

In a civilian cemetery near the town Abra de Ilog, Mindoro, there is a grave marked
"Major L. H. Phillips, U. S. Army, shot at Cabilagan by Nip Imperial Army March 15, 1944."

Phillips was given a military funeral by the Japanese.

2. If you will approve this report, I will submit it to the A.G. This will enable Captain Skundale to be promoted. At present there are no more vacancies for Majors in the Bn. T. O.

Phillips, 0916722, Corps of Engineers, Army of the United States, is cited for extraordinary heroism and outstanding gallantry in the presence of the enemy during the period 23 October 1943 to 15 March 1944, when as a volunteer for service of extreme hazard he established a radio and observation post in Northern Mindoro and transmitted therefrom to this Headquarters important information concerning enemy movements and dispositions. In addition to such service he was able, in the face of grave danger, to give encouragement and material aid to Americans and Filipinos still resisting the enemy on the Islands of Luzon and Mindoro. Subject: Report (The exhumation of late Major L.H. Philipps)

In the morning of April 11, 1944 I received a verbal order from Major Edwin P. Renssey, C.O., ECLGA, in Cabasiñgan, Abra de Ilog, Mindoro to exhume the body of doubted Maj. L.H. Philipps believed buried in the cemetery of Abra de Ilog, Mindoro. Due to complicated informations and rumors about the death of Maj. L. H. Philipps, we planned to exhume the body for examination in order to verify and prove his death.

Together with Cpl. Mateo Sisa, Pvt. Ciriaco Ramos (soldiers of Lts. Bernabe & Janilla) who were especially assigned to me, went by boat from barrio Cabasiñgan to barrio Matabang, Abra de Ilog and stopped in the house of barrio Leut., to take our lunch. After a few hours, we proceeded to the house of Mr. La Rosa contact-man in that town. According to Mr. La Rosa, the American being killed (whose name was also in doubt) was given a formal military burial by the Jap's Captain, formerly the Garrison Commander in that town, who happened to be a Catholic.

That night the Jap's P.O. were having a good time serenading around. Taking our chances, we slipped away to the bodega of the Municipal Building, where we were able to secure tools thru the help of Mr. La Rosa. I noticed that the cemetery is isolated from the residential building, except two (2) government buildings nearby. Back of the town school, facing the municipal building and opposite the town church. All these buildings are around five hundred (500) yards away from the cemetery.

It was very dark and busy around and we had a hard time locating the grave. The grave was marked by a wooden cross, about five (5) feet high and three (3) feet across with letters written in black paint, as follows:

When the grave was a long wooden stretcher almost covered by dry leaves falling from the trees nearby. We pulled it out and started digging. After an hour Cpl. Mateo Sisa, whispered that the ground he was stepping was already soft. I immediately lighted a match to find it out. The body was wrapped by the carabao hide and being buried about 3 feet below. The body was already very much decayed, so that all the human bones are exposed and completely beyond recognition. More or less the deceased was around 6 feet long. I completely open up the carabao hide being covered and noticed that

(over)

several ribs were fractured probably due to bullet hits. The skull was partly separated from the body. Finding no available things to be taken from the body for identification, I spade out the skull from the hole and examined it. Findings are mentioned below:

- (a) The skull was completely hairless.
- (b) Set of teeth on the lower jaw, complete;
- (c) One gold tooth on the right molar, upper jaw.
- (d) Three sets of gold teeth attached from the left molar to wisdom teeth, upper jaw.

It was impossible to take off the whole set of teeth which were attached to jaw bone. Instead I took of the gold teeth alone. (Submitted to Major Edwin P. Ramsey, C.O., ECLGA, and Mr. Wise, Warrant Officer, USA) on my return to Barric Caballigan, Abra de Ilog, Mindoro, on April 12, 1944.





Dear Col Whitney,

Everything has been fine. Chick is recruiting a Navy today!!! From observation he appears to be successful.

A few suggestions in regard to any future parties: Have had time to think this over. On boarding transportation each man should have a small pack. He should have at least the following:

1 ground sheet 1 blanket 1 pair shoes 1 pr jungle boots
2 complete change clothes; toilet articles and soap; 1 mosquito net; water proof bag; one carbine and one extra clip;
1 .45 cal pistol and two clips; 1 belt; 1 canteen; smokes. - 1 carbine
2 clips

This would enable each man to go at a moments notice to any designated spot and would be independent of the group as a whole.

Packing supplies: Too much emphasis can not be given this item.

Each box should be numbered and a complete list made of every article in the box. To label boxes medical supplies is not good, they should be itemized. In packing clothing for the men each members clothes should be packed separately to avoid confusion. The package should not weigh more than 100 lbs-50 lbs is better.

A list of supplies taken by the ISRM party is inclosed. This may assist future parties.

The money that was furnished has a very poor job of aging on the back of the bills. Something should be done to remove the artificial appearance. The money should be packed in five gallon tins. These would fit in a sack and would not attract attention. The container being used is too large.

All parts on the boxes of one radio set should be numbered 50 A- 50B 50C ~~50~~ so that it would be easy to set up one set in a hurry.

In some reading lately, I ran across a couple of items that might be quite useful in the future. Some Navy stills are described in the August 1943 Fortune magazine-page 74-78 which should be looked into for possible use on distilling alcohol.

Another item found in Colliers described a new compound Thiokol which could be used for lining a pit to act as storage tank for gasoline. It stated, that one transport plane could carry enough to make a storage tank equivalent in size to six room house. In this respect our transportation has two tanks which are capable of carrying 8000 gal gasoline each. This capacity could be greatly increased if the powers that be desired. The danger involved is plenty but so is there plenty of danger in carrying ammo.

Have had a number of ^{Sessions} ~~sessions~~ with Chick and have an ambitious program outlined. Will certainly have ~~it~~ a chance to give it a go.

He came here from Hial Crawford's Del Monte plantation of which he was the manager, was commissioned as Captain of Engineers and sent forward on an agricultural project with the understanding that when his services could be utilized in Philippine affairs he would be withdrawn.

His services are now urgently desired in the organization and training of Philippine parties and he is a logical choice himself for ultimate Philippine service.

There are few qualified men available to assist us in the furtherance of Philippine projects -- countless farmers and agricultural experts to develop purely agricultural projects. Hence when such qualified men are available the Philippines should receive high priority.

Request that the assignment of Captain PHILLIPS to this agency be approved despite the opposition indicated in the accompanying radiogram.

1. In order to permit this Bureau to amplify its training staff to meet immediate requirements resulting from the great expansion of the Philippine Regional Section, it is requested that:

Captain L. H. Phillips, (ASN unknown), Hq. Q.M.C., APO 929
be transferred to the Miscellaneous Section, USAFFE, for duty with AIB. CE 928

2. Captain Phillips has special qualifications which render him valuable for Philippine Regional Section training. It has been ascertained from Captain Phillips that his present assignment with the Q.M.C. has served its usefulness and that he now is relatively free from responsibilities. However, even though this were not true, it is believed that in view of Captain Phillips' qualifications, the Bureau should have prior claim on his services.
