TO : Regional Officer, Phillipine Regional Section
(Attention: Colonel C.W. Whitney)

1. From observance of past activities and in anticipation of increased activities in the future, the following matters are brought to your attention for consideration by your office.

a. The number of personnel at this point will be insufficient to handle the supplies and equipment which this office will be expected to receive, store and ship under the new program and it is recommended that the present force of five enlisted men be increased to a total of twelve men.
