For G-4/D8. Urmsg DA 87831, 7 April 51 refers. Mynsg C 59053 dtd 31 Mar 51. This message in two parts:

Part 1. a. Informal information indicates ammonium sulphate fertilizer is available in Japan. Request that a part program be issued soonest for procurement in FEC in lieu of ZI of equivalent repeat equivalent of 41,800 tons of ammonium sulphate or ammonium nitrate 32% plus contained as requested in para 7a ref msg.

b. Further request that additional funds in amount of \$4,100,000 be allocated to CINCFE to cover this procurement under requested part program. This part program necessary to permit immediate procurement and delivery of urgently required fertilizers to Korea.

Part 2. a. Part 1 urmsg DA 87831 reads "make settlement for CRIK POL issues in FEC." No rpt no local settlement made in FEC for transfers between services or issues GARIOA program. Former on authority DA WCL 34090 DTG 211500Z July 1950. Letter in accordance with SR 795-25-1, requisitioned in accordance with SR 730-5-1 and reported in accordance with SR-89015-1, change 1, 6 July 1950.

b. Request settlement for CRIK POL issues be made on same basis present GARIOA issues.

MEMO FOR RECORD:

SUBJECT: Part Program for Fertilizer for Korea

1. Mr. Boucher, ESS, gave Major Hunt, G-4 KEAD (Sup), the following information by telephone, 6 April 51:

a. Japanese Govt has 425,000 tons of ammonium sulphate stored in warehouses in Japan.

b. This contains 40,000 tons of nitrates, approx 10% contained.

c. Japanese Govt intends to liquidate this stockpile by 31 May 51 by selling to highest bidder.

d. This represents three months production in Japan which indicates that there is more than enough on the market to take care of Japanese needs.

e. Mr. Boucher felt that top level intervention by CINCPAC might persuade the Minister of Trade to divert this as an export item to Korea, particularly so since that which was normally exported to Korea was diverted to Formosa this year.

f. Price of this fertilizer is estimated at \$70.00 per metric ton FOB Japanese ports.

2. Since sustaining requirements for Korea for ammonium sulphate is 110,000 tons 32% plus contained, it would require approx 3 1/2 times as much of the Japanese fertilizer to meet this requirement, since it is approx .069% contained.

3. \$25,000,000 previously made available on allocation advice has been practically all committed. Therefore, additional funds are required in order to purchase subject fertilizer.

4. Para 7, msg C 59053, dtd 31 Mar 51, requested DA issue a part program for procurement in the ZI of 41,300 metric tons ammonium nitrate, 32% plus contained. Instant msg requests DA issue the part program soonest for procurement equivalent of 41,300 T ammonium sulphate 32% plus contained, and funds in the amount of \$4,100,000 be allocated to cover this procurement.

5. Part 2 instant msg recommends settlement for POL issues for CRIC be made at DA level not at theater level in the same manner as GARIOA issues.

ADDED M/R:

1. DA msg 87831, 7 Apr 51, indicates non-concurrence in CINCUNC's request for issuance of a CRIK part program to cover procurement of 41,800 metric tons of ammonium nitrate 32% plus contained nitrogen and 5800 metric tons super phosphate at estimated cost of \$4,104,000.

2. DA states also that the sustaining pipeline program to be supported by ECA funds provides for 110,000 metric tons of ammonium nitrate and 10,000 metric tons of super phosphate. Based on this pipeline, DA did not concur in CINCUNC's request for the above part program.

3. In view of the urgent need for fertilizers in Korea and the possibility of immediate procurement in Japan, it is felt that procurement of these fertilizers from CRIK funds can be accomplished more expeditiously than by the use of the ECA funds inasmuch as all procedures for expenditure of the subject ECA funds have not been delineated to date.

Part 1. Estimate reqstd in Part 1 of urmsg will be furnd soonest.

Part 2. Ref Part 2 of urmsg, shortage of critical MOS's thoroughly recognized here. Max sch and on-the-job training will continue here. Emerg reqns only for critically needed pers will be submitted.

Part 3. No difficulty contemplated in complying with sub para B 1a and b of Part 3 urmsg. However, do not concur in procedure outlined in sub para 1 b for folg reasons:

a. No provisions for such reasg of pers by water trans is provided by SR 330-400-1. Aforementioned regulations indicate FECOM will maintain accountability for such pers only until the day folg date of arrival at ZI port. Your proposal would req estab of EDCMR based on extended indefinite period of time and such pers would be chargeable to FECOM strength long after arrival in ZI and beyond normal "pipeline" time.

b. Direct asg of pers from FECOM units to ZI units will result in considerable difficulties in maintaining accurate strength accountability (both FEC and DA).

c. Consideration must be given to probability that some pers will turn in at hospitals, enter AWOL status, be apprehended by civil authorities, etc., prior to joining new unit in ZI and additional administrative burden will be imposed on this command in maintaining accountability and determining status of such personnel long after arrival in ZI.

Part 3. In view of above, recm folg procedure be adpoted which in general has been in effect for both off and onl pers departing FECOM for ZI since 1946:

b. Propose rtn of off pers tvlg with deps on first aval trans after max 21 day period in Japan even tho asg instrs have not been recd on same basis as ppsd for enl pers with dops.

Part 7. Ref Part 3 g of urmsg. CINCPAC msg C 59180 dtd 3 Apr 51 reqstd immed shpmt of 4 offs and 12 enl to arrive FECOM 15 Apr.

Memorandum for Record:

1. DA msg 87423 granted permission of request contained in CINCPAC msg C 57366 for repossession of the FPP Impedance. CINCPAC CX 59292 DTG 050139 Z directed CG, PHILCOM (AF) to immediately serve the required 30 days notice on the Manila Electric Co. under terms of the existing contract. The Impedance, when available, is contemplated for use at the Port of Pusan to alleviate the critical power shortage there.

2. Use of the Impedance at Pusan, operated in parallel with the Pusan steam plant, will permit retirement of the Jacona for use elsewhere. Feasibility is being explored of moving the Jacona to Inchon to use it in parallel with the Saranac to meet power requirements in the Seoul-Inchon area, provided a sufficiently deep anchorage can be found in such a location as will not require the use of an extensive length of submarine cable, and one affording some shelter from storms.

3. Use of the Jacona and Saranac in this manner, if feasible, will supplement the output of the Tangin-Ri power plant, provided repairs thereto can be effected and fuel supplied in ample quantities, thereby meeting all presently known power demands in Korea.

4. DA, in referenced message, requested information as to whether or not additional DA action is required to assist in alleviating the power shortage in Korea. Therefore instant message states present power requirements and relates the fact that future request for DA action is contingent upon the outcome of investigation as to feasibility of using floating power at Inchon. Instant message also requests DA determine the availability of Mr. Rall. It is proposed to use Mr. Rall to supervise the Japanese crew to be recruited to operate the Impedance.

1. Radio, DA 87320 DTG 312057 Z, states that ECA Mission in Korea is planning early discontinuance and requests information of capability of the Army to relieve ECA of Baltic Coasters transferred under an agreement between the Secy of the Army and the Administrator of ECA.

2. Representatives of the Army (Col Hensey, KEAD, G-4, GHQ, FEC; Lt Col Barton, G-4, GHQ, FEC; and Lt Cols Rehmann and H. E. Brown, Trans Sec, GHQ) attended a conference with RADM A. A. Burke, Deputy CofS, Naval Forces, Far East, to discuss the possible substitution of Navy operation for that by the ECA. Agreement was reached, for planning possibilities, that the Navy could operate the Baltic Coasters through the ROK Navy for the purposes stated to be desirable in support of the civilian economy of Korea.

3. This radio notifies the DA that relief of ECA probably cannot be accomplished in the Far East Command before 15 May 51 and states the plan to use the Navy as the agent for control of these vessels.

1. Based on assumptions stated urmsg, considered that previously indicated concept of ROK Army of 10 divisions and appropriate supporting combat and service units with total strength of 250,000 is still sound.

2. No change is recommended in ROK divisional organization approved by DA letter, "T/O&E for ROK Army Division", 12 March 51. Troop list of non-divisional combat and service support units, by type, and T/O&E for these units now under study and recommendations thereon will be forwarded soonest.



3. With regard to priority for the phasing and equipping of units, it is not practicable at this time to make sound recommendations on this matter. It would appear reasonable to assume that by the time allied ground forces are withdrawn from Korea the ROK divisions will have been fully organized and largely equipped. Thereafter priorities for equipping additional units will depend entirely on the situation existing at that time and, based on the assumptions stated urmsg, there appears every likelihood that assistance to and support of the NPRJ should receive higher priority than similar projects for the Korean Army.

2. From contents ref b and c it appears that events have overtaken plans, some of which are not in conformity with CINCUNC's understanding of agreements reached in Tokyo between CINCUNC, DA, State, ECA and Agent General, UNKHA, as expressed in ref a. In view confusing and conflicting contents ref b and c, it is essential that CINCUNC receive immediately a directive delineating CINCUNC's specific responsibilities for Korean relief and rehabilitation.

3. Situation here became more confused by receipt of reference c. In view of previous information received re ECA/Korea phase out, CINCUNC had directed that a draft of new aid agreement be prepared and held pending receipt of DA directive on entire matter. This draft will be completed and held.

4. An apparent misconception of UNKHA operations in the Far East has arisen. CINCUNC reiterates that CINCUNC does not repeat not desire that UNKHA take over Korean relief and rehabilitation until such time as peace and security have been established in Korea or appropriate designated portion thereof as determined by CINCUNC.

5. To provide for an orderly transfer of responsibility to UNKHA at a later date when the military situation permits, CINCUNC is agreeable that:
