I am astonished at the contents of your message 281024 Z, demanding that a special plane be sent from the US to Japan for the purpose of transporting you from Japan to Wilkes Barre Pa. I gave no promise to Congressman Flood or to anyone else that a special plane would be set up to take you from Tokyo to Wilkes Barre. The acute shortage of transport planes under WD control has been so well known to me that the making of any such promise or assurance in favor of any person would be an utter impossibility. It is also impossible to furnish a special plane to transport you from Calif to Wilkes Barre. Your transportation from Japan to this country is a matter that should be handled in Japan rather than from this end. You are not authorized to represent to anyone that any special promises or assurances in your case have been made by me.

Effective 31 Dec. 46 voluntary retention statements (As authorized in para 14, RR1-1, 18 March 46) signed by overseas non Regular Army EM (Excluding WACS) permitting retention in the Army for service beyond the date normally due for discharge under WD discharge criteria are cancelled. By 1 March 47 all such non Regular Army EM whose statements have been cancelled and who have not enlisted in the Regular Army will be aboard ship returning to the US for separation or will have been separated overseas in accordance with existing procedures. Personnel affected by this directive will be encouraged to enlist in the Regular Army. For your info ZI enlisted category statements are being cancelled effective 1 Nov.

Effective immediately any non Regular Army enlisted person who is within 6 months of attaining eligibility for separation under existing WD discharge criteria and who presents evidence in writing of acceptance for admission in an accredited college or university prior to the date he would normally be due for discharge will be returned to the ZI for separation for the convenience of the Govt. Priority for return of such individuals will be determined within your theater.

Desired this information be disseminated to subordinate field commanders overseas. Desired continental Army Area Commanders so inform all installations except class 3 installations within geographical limits their areas.

War Department radio WCL 46177 dtd 23 Sep 46 is amended as follows:

1. Part 1, para A (2) is amended by adding the following sentence: "Category 2 officers who do not desire retention will be released in sufficient time to complete all service including terminal leave prior 31 Dec 46."

2. Part 2, para 1, is amended by adding the following: "The prescribed length of service for separation eligibility of ASTP graduates must be in a commissioned status."

3. Part 3 is amended by adding the following: "Para 6. No officer may request release under the provisions of part 1 above after request for change of categories under provisions of part 4 has been approved. The period of active duty of an officer will not be extended by informal arrangements. Extensions may be made only with provisions of part 4."

Under heading "Subcommittee majority denies asking Hodge ouster in Korea," noon papers carry following AP release: "The majority of a house military affairs subcommittee denied today their chairmans claim that the group has recommended removal of Gen Hodge as Commander of United States troops in Korea . . . in a joint statement, Rep Short of Mississippi and Rep Martin of Iowa today expressed surprise at Mr Sheridans remarks and said they were "confident that no such agreement has been reached by the committee nor has the committee made such recommendations to the War Department." A 3rd member, Rep Sikes of Florida, said he knew of no such committee action. The group discussed the Korean situation with the War Department, Mr Sikes told a reporter, but it did not criticize General Hodge, While in Korea the committee complained of inadequate army supplies and facilities. Mr Short and Mr Martin commended Gen Hodge for "discharging his present difficult duties with credit both to himself and to the United States," and said he "deserved the wholehearted support of all our people." The 5th subcommittee member, Rep Johnson of California, is in Stockton, California.

News coming from Korea was confined to AP dispatch from Seoul dtd 26 Sep, in which Gen Hodge labled South Koreas railroad strike "an attempt by agitators to discommode and discredit American forces in Korea.



Morning papers carry following AP dispatch dtd 24 September from Philadelphia: "Representative John Sheridan, acting chairman of the House Military Affairs Committee, said tonight in an interview over radio station WIP that the Committee has recommended the removal of Lt Gen John R Hodge as American Commander in Korea. Sheridan said he conferred recently with General Eisenhower and told him of conditions he found on a recent visit to Korea. Sheridan and other members of the Committee visited numerous United States military installations throughout the world. Sheridan said morale of United States troops in Korea 'was the lowest' of any he has observed on his trip. He said troops were without fruit juices and such items as toothpaste." The broadcast itself was not carried on the Mutual Broadcasting Network, but was carried only locally by station WIP. Check on recording of broadcast indicates that AP quotation is accurate.

Desired this information be disseminated to subordinate field commanders overseas. Desired continental Army area commanders so inform all installations except class 3 installations within geographical limits their areas. Desired continental major AAF installation commanders so inform all class 3 installations under their respective commands.

Owing to recent stringent budgetary limitations and the desire to have a completely volunteer Officer Corps it has become imperative that the WD accelerate its demobilization of Officer personnel. The Officer strength of the Army will be reduced without delay in accordance with parts 1, 2 and 3 of this message. The changes in separation criteria indicated below will effect the release of Officers, including Officers of the Womens Army Corps, who will become eligible for separation by 30 June 47 under current Officer separation criteria with the exception of Med Dept Officers and critical specialists unless these Officers volunteer for longer service under the provisions of part 4 below. WD message WCL 39032, dtd 26 Aug 46, pertaining to demobilization of personnel of the Army is hereby rescinded.

Part 1. Officers other than Med Dept Officers except as indicated in paras 4, 5, 6, and 7 below, separation of Officers will be as follows:

A. Z of I.

(1). Category 5 Officers who will complete 24 months service by 30 June 47 and all category 3 and 4 Officers will be processed for separation immediately in order to complete all service including terminal leave prior to 31 Dec 46.

(2). Category 2 Officers will be released immediately unless such Officers desire retention for the period for which they volunteered but in any case they will be processed for separation in sufficient time to complete terminal leave by 30 June 47. No category 2 Officer who elects to serve for the duration of his volunteered service will be given a permanent change of station except in case of absolute necessity.

(3). Category 1, 6, 7, and 8 Officers who will have completed a minimum of 24 months total active duty may request relief from active duty. Request for such release will be made through channels and must be initiated prior to 1 Nov 46. Since release of category 1, 6, 7 and 8 Officers before expiration of their volunteer periods of service is an exception to policy requests initiated after that date will be returned by intermediate commanders without action. Commanders delegated approval authority under part 4 of this message will direct the separation of the Officers concerned as rapidly as military requirements will permit but in any event the Officers concerned will be released in sufficient

B. Overseas Theaters.

(1). Category 5 Officers who will complete 24 months service by 31 Dec 46 and all category 3 and 4 Officers will be returned to the Z of I for separation not later than 31 Dec 46. Terminal leave may or may not be completed by that date.

(2). Category 5 Officers who will complete 24 months service after 31 Dec 46 and prior to 30 June 47 will be returned to the Z of I for separation in sufficient time to complete their terminal leave not later than the day on which their 24 months service is completed. If desired by the theater commanders, these Officers may be returned immediately for separation processing.

(3). Category 2 Officers desiring early release may be returned immediately to the Z of I for separation processing but may be retained by the theater commander until replacements are available provided that they are returned to the US for separation in sufficient time to complete their terminal leave by 30 June 47.

(4). Category 1, 6, 7 and 8 Officers (except those with dependents overseas and those whose applications for travel of dependents to overseas theaters have been approved by the theater commander) who will have completed a minimum of

24 months active duty may apply for release from active duty. They may be returned to the US for immediate separation or held by the theater commander until such time as suitable replacements are available, but will be returned in sufficient time to complete terminal leave in their period of volunteer service. Request for such release will be made through channels to the theater commander and must be initiated prior to 1 Dec 46. Since release of category 1, 6, 7 and 8 Officers before expiration of their volunteer period of active service is an exception to policy and is done only because of budgetary demands, requests initiated after that date will be returned by intermediate commanders without action.

2. Commanders of all echelons will advise all Officers of the changes above and will take such action to change the record of Officers volunteer statements as may be appropriate. Insofar as military requirements will permit individuals separated under this authority will be reported for separation in the same relative priorities as would have been obtained prior to publication of this authority.

3. A. Effective on receipt of this directive and until 1 Nov 46 Officers departing ports of embarkation on permanent change of station to overseas theaters will be required to make a final commitment, reference para 1 A above, prior to shipment. A dated entry on form 66-1 or 66-2 over the

Effective two weeks after receipt of this directive and until 1 Nov 46 all orders directing movement of individuals to depots and ports for permanent change of station to overseas theaters will include a statement that the individuals listed have made the final commitment as to their volunteer statements and have signed appropriate entries to that effect on the form 66-1 or 66-2.

4. Scarce category Officers whose military occupational specialty appears in WD Cir nbr 321, 1945, as amended by WD Cir nbr 48, 1946, except civil affairs or military government Officers, may be retained in the service until replaced provided

they are utilized in their speciality but in no case longer than 6 months beyond date on which they would normally be separated or arrive in the continental US for separation under instructions in para 1 above. Civil affairs and military government Officers will be separated under the provisions of para 1 B above.

5. Officers whose military occupational speciality denotes linguistic ability and who are being utilized in such military occupational specialty will be separated not later than upon completion of 42 months of service including their accrued terminal leave unless they volunteer for longer extended active duty. Officer linguists not being utilized full time in their language specialty will be separated in accordance with the provisions of para 1 above.

6. OCS graduates will complete the term of commissioned service for which they contracted prior to separation under provisions of para 1 above.

7. Officers whose dependents have arrived or will arrive in the overseas theaters will serve the minimum of 1 year in the theater after the dependents have arrived before becoming eligible for separation.

4. All Med Dept Officers' surplus to requirements of major commands or returned to Z of I from overseas who are within 60 days of eligibility for release will be separated under the provisions of section 2, WD Cir nbr 290, 1945. *except those listed in para 3 above.*

Part 8. General provisions for separation.

2. 3. All Officers eligible for separation whose category statements are not upgraded in accordance with this part will be separated in accordance with parts 1, 2 and 3 of this directive. Any Officer who has failed to sign a category statement or whose category statement has expired and has remained on active duty without signing another category statement will be considered as a category 5 Officer for the purpose of separation under this directive.

4. No Officer who has commenced travel incident to processing for separation may request change of category of volunteer statements.

Under headline "Korea Red plot to drive Yanks from Southern Zone disclosed," AP release, with dateline Seoul 24 Sept, is repetition of yesterdays story by Simmons.

Walter Simmons, in dispatch to Chicago Tribune from Kaesong 23 Sept, said that the Japanese who continue to stream southward across the Russian guarded 38th parallel despite American protests, tell of being stripped of possessions, money, and papers by Russian troops and Koreans during their flight. As a result this camp, which has held as many as 10,000 refugees, must furnish all necessities to the penniless and exhausted Civilians... few able bodied are permitted to leave Russian held North Korea...the Russians have refused an American proposal for the orderly movement of repatriates from North Korea to Japan by ships. Officially, the Russians have taken the position that the southward flight is prohibited, but unofficially they appear to wink at the practice so long as the civilians aren't useful. Tribune also carried short article dateline Seoul 23 Sept, GI's were able to buy a \$1.25 tin of chocolate candy for 10¢ today as the result of a government juggling act. The candy, bought for PX's, filled warehouses in Manila at the wars end. The Army sold the surplus to UNRRA which earmarked it for relief in Korea. The Koreans disliked the candy and said they would prefer sugar. A swap for Army sugar was made on a virtual lb for lb basis. The Korean GI's, who have seen almost no candy in 2 months got a bargain when they were charged only for the cost of the sugar.

Walter Simmons, in dispatch to Chicago Tribune from Seoul 22 Sept, said that Communist plan to oppose with force the American Military Government's collection of summer grains in Southern Korea has been uncovered. "Top Secret" instructions calling for a fight led by women party members were seized by Korean Police at Fusan, on the Southeast Coast. The lengthy memo which members were cautioned to burn after reading denounced the Military Government and termed its policy "Many times as cruel as Hirohito's Barbarian Tyranny." Document said, "It is proper that we should assume the counter attack. We should fight against collection of summer grains energetically according to our precise plan. Search of houses should be stopped by a demonstration of the masses before it takes place. In that case, the women will be the vanguards and the men the rearguards. The principle of our methods is to make it look as if all villagers are fighting of their own free will. Therefore, names of organizations had better not be used." Disclosure of the document brought no comment from American Commanders who are well aware that Communist opposition to American Policies is directed by a daily outpouring of instructions from Russian controlled Korea. In Aug when Northern Korea Communists were merged into the new Labor party, the Pyongyang radio carried a disturbing report that "The Labor Party will organize the people as Military Power and institute a conscription system." These are only a few links in the chain of incidents in Korea recently. Singly,

Reference is made to a report to the Chief of Staff by Chairman Sheridan of the Congressional Committee which recently visited your command. Statements made by the committee pointed out the lack of PX supplies in Korea. Colonel O'Reilly has arrived and this radiogram has been prepared in coordination with him. Our information indicates that the following shipments are enroute to Korea: from San Francisco the Sea Barb and Joplin Victory departed 28 August 46 and 14 September 46 respectively with miscellaneous PX supplies including cigarettes, tooth paste, beer and candy. During September the Eliza P Perry, Marine Jumper, Omar Chapman and Oran Victory will depart San Francisco and will lift PX supplies. From Seattle SS Cleare departed 10 September 46 lifting all remaining PX cargo at that port. SS William F Cody arrived Honolulu 15 September 46 to pick up PX supplies from their QM and PX surplus and in addition 2,500,000 packages cigarettes purchased in Honolulu all for shipment to Korea. Shipments from Manila SS Charles Windsor arrived 17 September 46 to load 150,000 cases beer 500,000 bars soap as well as tooth paste tooth powder and other items. Colonel O'Reilly states the El Reno Victory arrived Korea near end of August with 2,600,000 packages cigarettes, also that PX sales in July and August were approximately \$1,354,000.00 and \$1,000,250.00 respectively which would average over \$20.00 per man per month. New York Times correspondent R J H Johnston, from Seoul 18 September, said early unification of Rightist and Leftist political groups in South Korea appeared certain here today. They will be led by Dr. Kimm, former vice chairman of the provisional Government in exile. DR. Kimm submitted a plan for unity last week that was favorably received in all political camps. With the virtual bankruptcy of the South Korean Communist Party, which has held other Leftist groups in line, agreement appears likely.

The strongest indication of the emancipation of the hitherto Communist dominated Leftist is the most recent statement made by Lyuh Heun Woon, of the Peoples party. He declared, "I am going to start again as head of the Peoples Party to set a new course. I demand that the Communists should get out of the party."

Both General Hodges and Major Arnold, delegate to the Joint United States Soviet Commission, yesterday issued statements applauding Dr. Kimms unification efforts and condemning the Communists demand that the government be turned over to the "The Peoples Committees." While reiterating that the proposed legislative body will not be a separate Government for South Korea and that United States authorities still regard the Moscow decision as

binding on both the United States and the Soviets, American Officials are going ahead with the plan to set up a Korean advisory body. If these plans succeed, the first part of 47 will find South Korea virtually selfgoverning under United States guidance.

Chicago Tribune carried story headlined, "Labor under Reds not free, Korea learns," by Walter Simmons dateline Seoul 17 Sept, "Numerous inconsistencies are found when Soviet proposals for reform in Japan are examined in the light of actual Russian performance in North Korea where 10 million persons live under the eye of the 25th Red Army." The article cited examples of Russian proposals for Japan with opposite action being taken in Northern Korea. "In Tokyo recently, the Russians have clamored for Civil Rights which the Japanese have already received from MacArthur. In north Korea, Freedom of the Press, Religion, Organization, and Demonstration is guaranteed under the Soviet regime but in practice the citizens are free to do nothing but support the Communist Rule...Labor is Soviet organized into one big union governed by laws which make no mention whatever of the strike privilege... The peasants have been saddled with a new 25% "Farm tax" payable in produce and based on quotas regardless of the ability to pay. Penalties for evasion range up to death... The peasants who received free land found there was a joker in the gift. They arent permitted to sell portions. They may also lose their farms for failure to meet production quotas."

New York Herald Tribune carried short article on the repatriation of 32,000 Koreans from North China, many of whom aided foe in War. The article, by A T Steele, dateline Tientsin 18 Sept said that Koreans were used extensively by the Japanese as the spearhead of their Narcotics program. Many



UNRRA has \$1,000,000 for procurement and delivery of relief supplies to all of Korea. Of this amount approximately \$200,000 set aside for transportation cost. Due to lack of commercial shipping, UNRRA unable to deliver these supplies. therefore, they proposed to US and Russian Military that \$400,000 worth of supplies be turned over to each in North America. The Russian Military to initially finance movement cost of supplies for Russian Zone and US Military to initially finance movement cost of items for US Zone. UNRRA further agreed to reimburse respective military for transportation cost incurred approximately \$100,000 to US Military approximately \$100,000 to Russian Military. Both Russian and US Military accepted UNRRA proposal. 300 tons clothes and shoes in question originally stated by UNRRA for distribution in US Zone only. Information received by WD from UNRRA 140100 Z shows that clothing and shoes to be distributed 50% US Zone 50% Russian Zone.

Request you suspend distribution in both US and Russian Zones pending completion of agreement with UNRRA on method of reimbursing WD for transportation cost on items to be distributed in Russian Zone.

Of the unordered items the bulk is textile items not yet in production and food items not yet available from processors. Other items on unfilled requisitions were received by the Army Exchange Service in New York within the last 2 weeks and are being ordered as rapidly as vendors will accept placement. 1,658,474 lbs Post Exchange supplies shipped to Korea since 1 June, half of which was shipped in Aug. Aug shipment included large quantities of cigarettes and candy. SS Cleare left Seattle 10 Sept lifting all remaining Post Exchange cargo at that port. Due to strike of seamen all shipments for Sept will be delayed. Vendors can not get permission to ship to port. Shipments will be expedited when strike is ended. 1. Public Law 670, 79th Congress, was enacted on 8th Aug 1946 and amends Public Law 281, 79th Congress, 28 December 45 (The enabling legislation under which the recent RA Officer Integration Program was conducted). It provides for the increase in the authorized strength of the Regular Army Officer Corps from 25,000 to 50,000 Officers and removes the time limitations during which the appointment under this law can be made. In order to advise you of the progress of current War Dept planning governing the Augmentation Program to be conducted under this new law, to outline to you your responsibilities under the new program and to solicit such recommendations as you may care to make regarding the proposed plans, the following basic information is transmitted.

2. On 28 June 46 the President nominated 9,813 Officers to be appointed in the RA under the provisions of Public Law 281, 79th Congress, and War Dept Circular 392 (1945 series). These nominations were confirmed by the Senate on 3 July 46, and all persons so appointed have been advised by the AG. Grade distribution of the newly appointed officers was approximately 6 percent Majors, 20 percent Captains, 62 percent 1st Lts and 12 percent 2nd Lts. Considerable difficulty was encountered in advising each of the new appointees due to redeployment and since many had failed to keep the War Dept advised of changes in address. 577 of those tendered appointments in June above declined

such appointments. On 20 August the War Dept recommended to the President 912 persons to be appointed in the RA to fill vacancies created by declinations from those tendered appointment in June and to balance attritional losses which have occurred in the RA during the months of July and Aug. These 912 appointments were approved by the President of 24 Aug 46 as recess appointments and should be confirmed by the Senate when that body reconvenes early next year. Appointees were advised by the AG on 16 Aug 46 by radio. Persons who were not selected under the current program and who have not been notified that they have been disqualified will be given further consideration for appointment in the RA. These persons will be considered together with the new applicants expected to apply when the next program is announced. There are approximately 70,000 persons on the consideration list. Such persons will be notified by War Dept letter of this fact during the month of Sept, 46. Persons remaining on the consideration list will have the opportunity of changing the arm or service 1st and 2nd choice and will be requested to submit the names of officers from whom additional officer evaluation reports may be obtained. These persons will be requested to execute a supplemental information form which will be transmitted to them with the War Dept letter advising them that they will receive further consideration for appointment.

3. Public Law 670, 79th Congress, 8th Aug 46, merely amends Public Law 281 in two respects.

A. It provides for the increase of the authorized strength of the RA 25,000 to 50,000 and

B. It removes any limitations to the time during which appointments under this authority could be made.

No other changes in that basic law were effected. Plans are currently under study to determine the branch and grade distribution of the authorized increase. It is contemplated that the greater proportion of the additional 25,000 officers will

be integrated into the RA within the ensuing year. The balance of the vacancies will be retained to afford opportunity for RA appointment to graduates of ROTC Units, reserve and National Guard Officers on extended active duty, and honor graduates of OCS.'s.

4. A War Dept circular governing the next intergration program is being prepared and involves considerable operational responsibility and activity for the commanders of overseas theaters and departments, Zone of Interior armies, and the Mil Dist of Washington. It is contemplated that these commanders will be responsible for the establishment, operation and maintenance of the necessary officer screening centers to include the establishment of Officer Interview Boards, Medical Examining Team Field Processing and Field Publicity.

5. The Chief of Staff has announced a policy which provides that applicants for Air Corps will be interviewed by a board of officers composed solely of RA Air Corps Officers. Applicants who elect Air Corps as one of their choices, and another arm or service as the other choice will appear before both an Air Corps Interview Board and a Ground Arms and Services Interview Board. The Air Corps Interview Board report is to be used only when the applicant is being considered for appointment by the CG, Army Air Forces. Personnel to man Air Force Interview Boards and Air Corps Medical examining personnel will be provided for Zone of Interior Army Commanders by the CG, Army Air Forces. Theater and departmental commanders will utilize Air Corps Personnel under their jurisdiction.

6. It is contemplated that all new and retained applicants will submit their application or supplemental forms to the AG through the theater or Zone of Interior Army Commander. Such a channeling method will permit the theater and Army Commander to maintain a record of all persons being considered for RA appointment who are residing or stationed within his area.

7. Although the exact timing schedule is not yet established, the following advanced information is presented to indicate

A. The War Dept circular governing the next intergration program will probably be published and distributed in the field prior to 15 Oct 46.

B. The application phase of the program will cover the period from 15 Oct 46 through 31 Dec 46.

C. Officer screening centers will operate during the period from 1 Dec through 31 March 47.

D. During the period from 15 Oct 46 to 31 Dec 47 appointments will be made in four increments as follows:

Your attention invited WD cir 217 dtd 20 July 1946 in regard financing and reporting costs of care and handling Army surplus property. It has been mutually agreed by the OFLC here, WSA here and WD that the following procedures will govern shipments of Army surplus materials sold by OFLC as to ocean transportation costs.

1: OFLC Washington will make formal written requests to the WD to provide transportation for the movement of Army surplus goods in those instances and to those destinations where the recipient government involved has no dollar exchange or dollars available for the payment of ocean transportation.

2: When transportation responsibility has been accepted by the WD the Theater Commander will be authorized to request the WSA Maritime Commission in the Theater to furnish necessary shipping through the usual channels.

3: WSA Washington will instruct general agents of the vessels involved to submit billings for the voyage to Finance Office in the Theater where the shipment originates for payment at agreed freight rates.

One American soldier died of deadly Japanese type encephalitis and two are seriously ill at an isolated detachment of 1500 Yanks 100 miles south of Seoul, Dr. Albert Sabin reported today. He also told a conference of Army doctors, that all personnel in the detachment have been inoculated.

Special, to New York Times, Seoul, Sept 4. The Southern Korean Communist controlled press, in a belated reaction to statement of American intention here by Lt Gen Hodges and acting Secretary of State, Dean Acheson, vigorously denied the existence of a "well organized" propaganda factory from which criticism of the United States and its policy here, the most radical papers, Chosun Inmin Po and Hyun Dai Ilbo, carried the statement which declared that criticism was inspired by the "fact that the Military Government has been employing all former officers who worked for the Japanese Regime." It argued that the extension of American credit would cause Korea to "accumulate foreign debts without economic reconstruction" and that surplus American goods would not meet demands.

UP release in noon press today datelined, Seoul, Sept 6. Military Police simultaneously raided three Korean Communist newspapers today and suspended them on grounds they were "endangering the security of United States Army Forces in Korea." The Army announced several people had been taken in custody and would be prosecuted in

Military Courts for violating a Military Proclamation issued last year. Observers regarded today's action as the inevitable follow up of a sharp indictment issued recently by General Hodges. General Hodges attacked "harmful propaganda practices" which allegedly were being employed by "a minority of political groups." These groups were attempting to discredit the American effort to assist in the rebuilding of Korea he said. The three papers were the Chosun Inmin Po, official organ of the Korean Communist Party, the Hyun Dai Ilbo and the Choon Ang Sin Moon, which are regarded as sympathetic to the Communist Party. Chosun Inmin Po gave prominence to reports on August 15 that American troops allegedly bayoneted Korean laborers in South Korea and has claimed that the United States is attempting to colonize Korea. The latter accusation has been broadcast by radio Ypong Yang, Headquarters for the Russian Command in North Korea.

The Canadian Govt has inquired whether there is US objection paying current and back pensions in Japan to approx 22 Canadian Veterans or widows, mostly from World War - I, some technically British by naturalization, balance Japanese Nationals. Propose pmt directly by diplomatic mission with Yen purchasing by deposit here of US Dollars which will go into trust fund under present remittance procedure. Present US policy in Public Law 622, 7 Aug 46, covering resumption pmt of pensions and benefits to US Veterans or their dependents in former occupied areas, contains Senate rider forbidding pmt to any Japanese or German Nationals resident in Japan or Germany in absence of uniform Allied policy. Interested Govt Agencies here do not object to Canadian proposal. Request your views soonest.

Only item of note in today's press concerning charges made by representative J E Sheridan carried by New York Times dateline, Yokohama, Sept 4, is quoted in part--- "Major General Eichelberger himself refused to comment, Army records here indicate that Mr Sheridan made a series of errors in reporting the picture in Korea. The principal among them was the matter of responsibility. This statement that the morale in Korea was at its "lowest ebb" and "that nowhere in the world have we received so many complaints and on inquiry found them wholly justified" directed the protest. But, the 24th Corps, which occupies Southeast Korea, is not and never has been since Japan's surrender a part of the 8th Army and its morale is the direct responsibility of its Commander Lt Gen John Hodge, and Gen Douglas MacArthur, not of Gen Eichelberger. Mr Sheridan also reported that at a post exchange at one airfield, no goods were available---"No popular brands of cigarettes, not even a pair of shoelaces for the Commanding General." Official Army reports from Korea show that on Aug 15 the 24th Corps had on hand---according to its own figures---3,000,000 packages of standard brands of cigarettes, or about six weeks supply. In addition, 2,600,000 packages were shipped to Korea from here "On or about Aug 10." Other figures here quoted to answer the rest of Mr Sheridan's charges."

Widely used in stateside press (3 Sept) AP dispatches over both UP and AP wires reporting criticism by Congressmen of morale services to troops in Korea.

UP, Seoul, 2 Sept: Representative John E. Sheridan, Acting Chairman of the House Military Affairs Committee, today sharply criticized the food, recreation and post exchange service provided for American soldiers in Korea.

In a letter which he himself termed a "most serious indictment" to Lt General Robert Eichelberger, 8th Army, Commander, Sheridan asserted that Army morale in Korea is "at its lowest ebb." The Congressman wrote the letter after a one day visit to Korea.

Sheridan said: "Nowhere in the entire world where we have inspected military installations have we received so many complaints and on inquiry found them so wholly justified."

High Army officials in Seoul, admitting the truth of the charges, blamed the situation on the changeover of supply personnel and said they expected normal conditions within three weeks.

AP, Seoul, 2 Sept: Almost identical in substance to UP dispatch quoted above. No editorial comment noted on above reports to date, but some radio comment reflecting the reports in "regretable" light.

Widely used as front page story in today's press is report of statement issued 30 Aug by State Dept in Wash, the first formal statement from Wash on Korea since Moscow Foreign Ministers Conference last Dec. Acting Sect of State Acheson, in giving out the official statement, said General Hodge would make a public statement along the same lines.

Acheson revealed that General Hodge has been instructed to assure the Korean people that the United States will uphold its commitments "and will stand by them until these commitments are fully achieved." Acheson stressed United States is prepared to resume discussions with Russia looking toward a united and independent Korea any time the Russians are willing, and added the sole reason our forces are in Korea is to aid the Korea people to achieve their independence under a united, independent and democratic government. Emphasizing the United States has no imperialistic aims in Korea, the State Dept announcement nevertheless added that this government intended to keep its troops in Korea until "Our objectives" have been attained.

The State Dept said that in view of the delay in uniting Korea the United States would proceed with the solution of urgent "Social and economic problems in our zone" along lines reflecting the will of the Korea people.
