Sir:

In accordance with our agreement, we are placing the ss "Panay" at your disposal this morning at Pier 1. We understand that a formal contract will be drawn today or tomorrow, but in the meantime this letter will serve as a memorandum agreement.

The U.S. Army and the Compania Maritima agree on the following:

1. The ss "Panay" is chartered by the U.S. Army beginning from the moment the ship has docked at Pier 1 this morning.
2. The ship will be subject to all Army orders, except that it will not be sent beyond Philippine waters.
3. All passenger and cargo capacity of the ship is reserved for the Army.
4. The Army will, in case of accident, compensate the officers and crew in an amount equivalent to two years salary in accordance with schedule attached, this amount to be given as one total payment.
5. The Army will guarantee shipowners for partial or total loss of the vessel in the amount of five hundred thousand dollars. This responsibility covers war and marine risks.

We inform you that the ship carries some insurance covered in London but we are not certain whether the ordinary commercial insurance will be held valid if the ship is used by the armed forces. It is agreed, therefore, that the Army covers the ship against war and marine risks in the above mentioned amount of five hundred thousand dollars.

6. This agreement is for trip charter, one round trip from Manila out and back to Manila to be considered one trip. Payment for the trip will be twenty thousand pesos for every trip, which will not exceed one week. If the trip lasts longer than a week, payment will be pro rata on the basis of twenty thousand pesos for seven days.

From Compania Maritima to Traffic Control Officer, U. S. Army.

7. Our obligation is subject to being able to continue to be supplied by the Asiatic Petroleum Company or any other oil company with oil at a price not over forty pesos per ton, unless the Army gives us oil at this price.

8. Our obligation is also subject to ordinary reservations of failure to comply due to force majeure causes.

We inform you that the ship carries some insurance covered in London but we are not certain whether the ordinary commercial insurance will be held valid if the ship is used by the armed forces. It is agreed, therefore, that the Army covers the ship against war and marine risks in the above mentioned amount of five hundred thousand dollars.

6. This agreement is for trip charter, one round trip from Manila out and back to Manila to be considered one trip. Payment for the trip will be twenty thousand pesos for seven days.

7. Our obligation is subject to being able to continue to be supplied by the Asiatic Petroleum Company or any other oil company with oil at a price not over forty pesos per ton, unless the Army gives us oil at this price.

8. Our obligation is also subject to ordinary reservations of failure to comply due to force majeure, causes.

a)-The per trip/of P20,000.00 was so fixed because of the increasingly longer time taken in loading and unloading operations. The time taken up in loading and unloading operations was not to be included in determining compensation should the trip exceed seven days.

b)- The signed copy of this letter is in the possession of Compañia Maritima and will be surrendered upon request.

- 5.- No money or compensation of any type has been received to date by the Compañia Maritima, or by any of its representatives, either as rental, or as a partial or total settlement for the charter and loss of the S.S. PANAY.
- 6.- The S.S. PANAY was one of the several ships mortgaged to the Philippine National Bank to cover general overdraft and banking facilities at the time it was taken over by the U.S. Army. These overdraft and banking facilities subsequently were paid off and the mortgages, cancelled, so that there is now no outstanding lien or mortgage against the S.S. PANAY.
- 7.- After the property was taken as above, it was bombed and sunk on December 30, 1941 (see paragraph 3-e).
- 8.- I swear that the above statements are true to the best of my knowledge and belief, that we are the owner of the above described property, and are legally entitled to receive payment thereof, that the claim is just and valid; and that IN CONSIDERATION of the payment of US\$510,000.00 calculated as follows: US\$500,000.00 for the total loss of the S.S.  - c)- On December 25, 1941, the U.S. Army ordered the S.S. PANAY to proceed to Corregidor, which order was complied with.
 - d)- On December 28, 1941, under sealed instructions from the U.S. Army, the S.S. PANAY left Fort Mills, Corregidor.
 - e)- On December 30, 1941, while the S.S. PANAY was anchored at Ilin Island it was bombed and sunk by Japanese bombers.

I started to work for Army Transport Service on 22 Dec 1941 on Board the S/S Panay - loaded with arms & ammunition and O M Supplies headed for Southern forces. On 29 Dec 41 - 4 Japanese Bombers sighted the ship on Maricalum Bay, Southern Negros Island. The Panay was bombed and hit causing fire and ship sank at 3 o'clock AM on 30 Dec 1941. After the ship sank we swam to shore, Maricalum Bay - during the day the Mayon a Boat ~~came~~ coming from Corrigedor just ashore - our crew was taken ~~aboard~~ ^{aboard} and we left Maricalum Bay at 5 PM 12/30/41, headed for Bugo, Mindinao. ~~we~~ we landed on Bugo during the day of 31 Dec 1941. - after unloading soldiers we proceeded to Cebu City, Cebu arriving there 1 Jan 42.  - a) On December 22, 1941, the S.S. PANAY was ordered to Pier No. 1, Manila, by the U.S. Army where it was loaded with military cargo, by the U.S. Army authorities. Loading operations continued on the 23rd and 24th of December, 1941.
 - b) On December 25, 1941, the S.S. PANAY under orders of the U.S. Army anchored outside of the breakwater awaiting further orders.
 - c) On December 25, 1941, the U.S. Army ordered the S.S. PANAY to proceed to Corregidor, which order was complied with.
 - d) On December 28, 1941, under sealed instructions from the U.S. Army, the S.S. PANAY left Fort Mills, Corregidor.
 - e) On December 30, 1941, while the S.S. PANAY was anchored at Ilin Island it was bombed and sunk by Japanese bombers.
 - f) The S.S. PANAY although under orders of the U. S. Army was manned and operated throughout this period by the officers and crew of the Compania Maritima.
4. The value of the ship when taken by the U.S. Army was US\$500,000.00, and the charter was ₱20,000.00 per trip, from Manila out and back to Manila, provided it would not exceed seven days which was agreed to as is evidenced by the following memorandum agreement:

"Manila, December 23, 1941.

The Traffic Control Officer
Quartermaster Department
U.S. Army
Manila

Sir:

In accordance with our agreement, we are placing the SS 'Panay' at your disposal this morning at Pier 1. We understand that a formal contract will be drawn today or tomorrow, but in the meantime this letter will serve as a memorandum agreement.

The U.S. Army and the Compania Maritima agree on the following

1. The ss 'Panay' is chartered by the U.S. Army beginning from the moment the ship has docked at Pier 1 this morning.

2. The ship will be subject to all Army orders, except that it will not be sent beyond Philippine waters.

3. All passenger and cargo capacity of the ship is reserved for the Army.

4. The Army will, in case of accident, compensate the officers and crew in an amount equivalent to two years salary in accordance with schedule attached, this amount to be given as one total payment.

5. The Army will guarantee shipowners for partial or total loss of the vessel in the amount of five hundred thousand dollars. This responsibility covers war and marine risks.

We inform you that the ship carries some insurance covered in London but we are not certain whether the ordinary commercial insurance will be held valid if the ship is used by the armed forces. It is agreed, therefore, that the Army covers the ship five hundred thousand dollars.

6. This agreement is for trip charter, one round trip from Manila out and back to Manila to be considered one trip. Payment for the trip will be twenty thousand pesos for seven days.

7. Our obligation is subject to being able to continue to be supplied by the Asiatic Petroleum Company or any other oil company with oil at a price not over forty pesos per ton, unless the Army gives us oil at this price.

8. Our obligation is also subject to ordinary reservations of failure to comply due to force majeure, causes.

a- The per trip charter of ₱20,000.00 was so fixed because of the increasingly longer time taken in loading and unloading operations. The time taken up in loading and unloading operations was not to be included in determining compensation should the trip exceed seven days.

b) The signed copy to this letter is in the possession of Compania Maritima and will be surrendered upon request.

5. No money or compensation of any type has been received to date by the Compania Maritima, or by any of its representatives, either as rental, or as a partial or total settlement for the charter and loss of the S.S. PANAY.

6. The S.S. PANAY was one of the several ships mortgaged to the Philippine National Bank to cover general overdraft and banking facilities at the time it was taken over by the U.S. Army. These overdraft and banking facilities subsequently were paid off and the mortgages, cancelled, so that there is now no outstanding lien or mortgage against the S.S. PANAY.

7. After the property was taken as above, it was bombed and sunk on December 30, 1941 (see paragraph 3-e)

8. I swear that the above statements are true to the best of my knowledge and belief, that we are the owner of the above described property, and are legally entitled to receive payment thereof, that the claim is just and valid; and that IN CONSIDERATION of the payment of US\$510,000.00 calculated as follows: US\$500,000.00 for the total loss of the S.S. PANAY, and US\$10,000.00 for the trip charter, the UNITED STATES OF AMERICA, its officers and agents, are HEREBY UNCONDITIONALLY RELEASED from all further liability arising out of the above claim.
