AFFIDAVIT

I, Victoriano U. Blancas, Captain, Inf., PA., at present on duty as Investigating Officer, Claims Service, AFWESPAC, certify as follows:

From 1 April until 22 May 1942 I was the Commanding Officer of the Bohol Provisional Regiment, USAFPE under the overall commend of Major General William Sharp, Commanding the Visayan-Mindanso Forces.

Sometime during the month of April 1942 I received a radiogram from General Sharp ordering me to commander all beats and send them to Mindenso for the purpose of trensporting food, troops and supplies. These instructions were given to Ceptain Leonardo C. Torres who was in command of troops in Tagbilaren, Bobol. Therefore, in my opinion Captain Torres was eating within his authority at the time that he commandeered the M/S "MASAYON" on 25 April 1942.

Sometime during the latter part of April or early in May 1942 I was in Tagbilaren to determine what ships had been commandeered under instructions issued by me and to determine if said ships had been sent to Mindamao. While I was there, the motor ship "MASATON", acting under USAFFE orders left the port of Tagbilaren with the intention of proceeding to Mindamao. After that I have no further personal knowledge of the whereabouts and disposition of the NS "MASATON".

At the time of commandeering it was understood between the USAFFE and the owner of the boat that the salaries of the crews would be paid by the USAFFE.

A pertial payment was made to the members of the crew for the benefit of their families. All of these records were in the hands of it. Felipe S. Fizerro, Finence Officer, Sohol Forces USAFFE and I have no personal knowledge of the exact amount which was paid to the crew members.




