

1. The following comments are offered on the subparagraphs of Par 1:

- a. Concur; with some exceptions, it disappeared.
- b. During this time the organized resistance was by guerrilla units, many of which were early recognized.
- c. Concur; the source of manpower for the new Philippine Army would be recovered USAFFE and civilian guerrillas, largely the latter. First, came the recognition; the unit was henceforth in the Philippine Army (by Executive Order #21), either on T/O & E or not, as the case might be.
- d. Concur; the expansion of the Philippine Army to contemplated size was suspended many recognized units were already standard (i.e., T/O & E) elements of the Philippine Army and many other recognized units were still under their guerrilla (non-T/O & E) organization. Unrecognized guerrilla units, then as now, sought recognition.
- e. (1) Concur.  
(2) Such redesignation occurred generally after our landings.  
(3) Concur; with the recommendation that "establishing" be replaced by "continuing," as the recognized unit continued its guerrilla organization and name.

1. Confirming the result of the conference on 6 January 1947, between Colonel Lillard, Chief of your Branch and Lieutenant Colonel Basil A. Wood, Chief of Claims, your concurrence in the following statements is requested:

a. After the surrender of the Armed forces to the Japanese in 1941 and 1942, the units of the Philippine Army, the Philippine Constabulary and the Philippine ROTC, for all intents and purposes, disappeared.

b. During most of the months of Japanese occupation of the Philippine Islands the only organized resistance was limited to unrecognized units, which have been subsequently classified as Guerrilla Units.

c. Prior to making a landing in the Philippine Islands, USAFFE planned to re-establish the Philippine Army as soon as the landing was effected, and for that purpose brought into the Islands many individual officers of the old Philippine Army. This plan included calling into the Philippine Army, guerrilla units that had proved their value, establishing and recognizing and where desirable, redesignating the guerrilla units as a component part of the Philippine Army. This plan was put into effect and followed throughout the subsequent months.

d. Due to the collapse of Japanese opposition, the designation of the units in the Philippine Army was never completed, so that at the time of the surrender, some Guerrilla Units had been designated as component parts of the Philippine Army, and other Guerrilla Units were presenting supporting data and facts, for the purpose of obtaining recognition.

e. The effect of recognizing a unit or force of guerrilla is

(1) To call that unit or force into the Philippine Army, effective according to the recognition date, even during

the months of Japanese occupation, placing this unit on equal footing with other component parts of the Philippine Army, either by

(2) Redesignating it as a STANDARD component part of the Philippine Army, with table of organization, or

(3) Establishing a unit as a NON-STANDARD component part of the Philippine Army, without a table of organization and without redesignating the unit, at this time.

2. Officers of the Army of the United States or of the United States Regular Army assisted in the establishing of the resistance movement, serving as officers of the Guerrilla Units during the months of Japanese occupation and subsequent months, to the liberation. The recognition of the unit or force of the Guerrilla with which such officers served, does not affect their status. These officers are not considered on the roster of officers made a component part of the Philippine Army, but are carried on the roster of their original organization, and pay and allowances have been paid based on such roster.
