SUBJECT: Revocation of Revised Recognition Dtes.,
Pampanga Military District, ECLGA

TO : Chief Of Staff Armed Forces Of The Camp Murphy, Quezon City

1. Extensive reinvestigation and reconsideration of the Pampanga Military District, ECLGA, a guerrilla Unit recognized by the Commanding General, Sixth Army, and the Commanding General, AFPAC, in an approximate total strength of 2211 and with initial date of recognition of 1 February 1945 for some elements thereof, and subsequently extended revision of initial recognition date of some elements to 15 May 1942 by letter, Headquarters AFWESPAC, dated 10 December 1946, revealed that there existed insufficient justification for the revision of recognition dated granted this unit.

2. Protracted reinvestigation revealed that the Pampanga Military District failed signally to attain the standards required to substantiate official recognition as an element of the Philippine Army in the service of the Armed Forces of the United States prior to the date of its initial recognition in 1945. Its record of service for this period was not substantiated by sufficient acceptable evidence. Available evidence indicates that the members of the Pampanga Military District served as homeguards for the period in question and did not make any material contribution to the war effort.

3. It is therefore announced that the existing revised recognition date of all members of the Pampanga Military District, ECLGA, established by letter, this headquarters, dated 10 December 1946, subject: "Revised of Recognition Dates for the East Central Luzon Guerrilla Res (ECLGA)," is revoked. 
Such members of the above-listed units of the Pampanga Military District, ECLGA, declared in the status of an unrecognized guerrilla for the period to his initial recognition date in 1945

It is requested that the Pampanga Military District, ECLGA, and of its composing elements (including squadrons, the Northwest Pampanga Military District, ECLGA), be deleted from the list of recognized guerrilla units of the ECLGA authorized revision of recognition dates by letter, Headquarters AFWESFAC, dated 10 December 1946.
