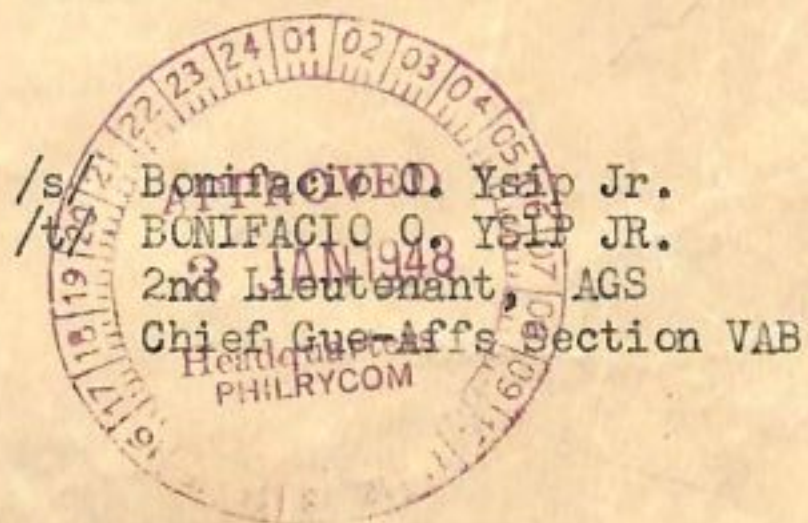

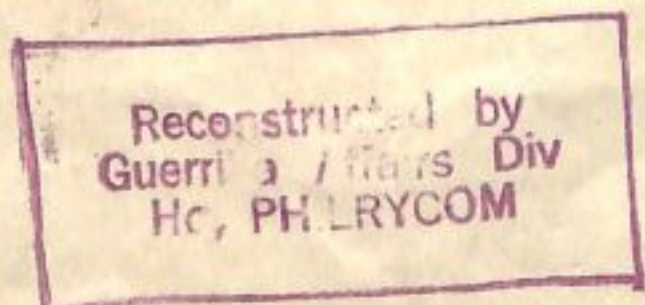

SUBJECT: Request for Confirmation of Muster List

TO : C. O., 67th Signal Battalion, APO 198

1. The Regional Finance Officer (PA), attached to LAC has called our attention to the apparent discrepancy in our present muster list from that of the original which was approved and recognized by the Sixth Army as of 9th April 1945. Investigation at AFPAC revealed that the only muster list they indeed have is that of the first contingent that reported at Canlubang, Laguna, which is 123 Offs and EM.

2. However, subsequent to the first contingent, other groups were requested for by the C.O. 88th Signal Bn, until a maximum total strength of 221 Offs and EM was weeded out, until a basic strength of 6 Offs and 175 EM remained. As you will notice from the accompanying enclosures, this strength was made the subject of communications for recognition of this unit between the 88th Signal Battalion and the 8th Army.

3. Until 15th August 1945, date of detachment of this unit from the 88th Signal Battalion, personnel records, payrolls, request for promotions and demotions of Officers and Enlisted Men, and communications to the different Army Headquarters in the interest of this unit, was the exclusive responsibility of S-1, 88th Signal Bn.

4. You will also notice from the attached pay vouchers for the months of June, July, August and September, 1945, Officers and Enlisted Men included in the said muster list have regularly been paid. June, July, and August pay vouchers were prepared by the S-1 and duly approved by the C. O. 88th Signal Battalion.

5. In view of the above, it is therefore requested that the said muster list composing 6 Officers and 175 Enlisted Men be confirmed, to supersede the original muster list of 7 Officers and 116 EM, as of 9th April 1945.
