

1. The request of Sofio L Josol, dated 9 May 1947, for individual recognition in the rank of 2nd Lieutenant and the inclusion of his name on the recognized roster of Live or Die (LOD) Unit, 10th Military District, has been investigated.
2. The request is disapproved in the rank of 2nd Lieutenant but approved in the rank of 3rd Lieutenant. His period of recognition will extend from 20 May 1944 to 20 July 1944.
3. It is recommended that the name of this individual be inserted with the rank of 3rd Lieutenant in the roster of Live or Die (LOD) Unit, 10th Military District by issuance of appropriate orders.
4. It is further recommended that the subject individual be paid for such period within the above dates as may be recognized by existing laws and regulations after adjudication and approval by the Recovered Personnel Division of this headquarters.

SUBJECT: Recognition of Guerrilla Unit.

TO : Chief of Staff
Army of the Philippines
Camp Murphy, Quezon City

1. The unit listed below is recognized by the Commanding General, Philippine-Ryukyus Command, as having been an authorized element of the Philippine Army, serving with the Armed Forces of the United States from 1 December 1942 to 20 July 1944.

Live or Die (LOD) Unit, 10th Military District	74

2. Members of the above unit will be recognized from 1 December 1942 or date of induction, as indicated on attached roster, which ever is later, to 20 July 1944.

3. Under the provisions of Executive Order No. 21, by the President of the Commonwealth of the Philippines, dated 26 October 1944, the status of the members of this unit, during the period above specified, was that of officers and enlisted men of the Philippine Army.

4. Under the provisions of Executive Order No. 68, by the President of the Commonwealth of the Philippines, dated 26 September 1945, all officers and enlisted men of this unit, other than those who are members of the Regular Force or the Reserve Force of the Philippine Army, will be considered as having been discharged from the Philippine Army as of 20 July 1944.

5. The period of recognition listed in Paragraph 1, above, constitutes the entire determined period of active military service of this unit with the Armed Forces of the United States and reflects final study on revision of recognition dates.
