
Reasons for difference between strength previously recorded and actual recognized strength:

1. - - - - individuals deleted because their names were duplicated on recognized roster.
2. - - - - individuals deleted because their names are listed with another element of the unit.
3. - - - - individuals deleted because their names were previously inserted on the roster without authority.
4. - - - - individuals added because their names were previously deleted from the roster without authority.
5. - - - - individuals added because an authentic supplementary roster not previously listed is now included with unit.
6. Other reasons 33 individuals were deleted by ltr, Hq PHILRYCOM, dtd 3 Jan 48, because they appear on the recognized roster of the Co "A", Lubang Special Battalion whose recognition was revoked by this Hq, dtd 9 Aug 47.
7. This roster constitutes the only authentic official recognized roster of the above named guerrilla unit.

SUBJECT: Correction of Recognized Roster, Lubang Volunteer Company

TO : Chief of Staff
Armed Forces of the Philippines
Camp Murphy, Quezon City

1. The recognized roster of the Lubang Volunteer Company, consisting of 110 members, date-stamped 10 June 1947 and approved by letter from this headquarters, GSCPU 091 PI, dated 13 June 1947, subject, "Recognition of Guerrilla Unit," is hereby rescinded in its entirety.

2. Request that the attached corrected roster of subject unit, consisting of 77 members, date-stamped 20 December 1947, be substituted in lieu of the rescinded roster.

3. Investigation reveals that the names of thirty-three (33) individuals listed on the recognized roster of the Lubang Volunteer Company dated 10 June 1947, were also listed on the recognized roster of Company A, Lubang Special Battalion, whose recognition was revoked by letter from this headquarters, dated 9 August 1947. Inasmuch as these 33 individuals as members of Company A, Lubang Special Battalion, were declared in the status of unrecognized guerrillas without any period of recognition whatsoever when the recognition of that unit was officially revoked on 9 August 1947, the deletion of their names from the roster of the Lubang Volunteer Company is considered mandatory, reducing the total recognized strength of that unit to 77.

4. It is requested that the rescinded roster of the Lubang Volunteer Company, dated 10 June 1947, be returned to this headquarters.

5. The attached corrected roster of the Lubang Volunteer Company, dated 20 December 1947, constitutes the only official recognized roster of that unit.

SUBJECT: Recognition of Guerrilla Unit

TO : Chief of Staff
Army of the Philippines
Camp Murphy, Quezon City

1. The unit listed below is recognized by the Commanding General, Philippines-Ryukyus Command, as having been an authorized element of the Philippine Army, serving with the Armed Forces of the United States, from 16 February 1945 to 26 March 1945.

<u>Unit</u>	<u>Strength</u>
Lubang Volunteer Company (Independent)	110

2. Under the provisions of Executive Order No. 21, by the President of the Commonwealth of the Philippines, dated 26 October 1944, the status of the members of this unit, during the period above specified, was that of officers and enlisted men of the Philippine Army.

3. Under the provisions of Executive Order No. 68, by the President of the Commonwealth of the Philippines, dated 26 September 1945, all officers and enlisted men of this unit, other than those who are members of the Regular Force or the Reserve Force of the Philippine Army, will be considered as having discharged from the Philippine Army as of 26 March 1945.

4. The period of recognition listed in Paragraph 1, above, constitutes the entire determined period of active military service of this unit with the Armed Forces of the United States and reflects final study on revision of recognition dates.
