4. All data contained herein are furnished on the sworn statement of the recognized guerrilla leader. They are accepted as official data upon which payment of arrears in pay may be adjudicated unless official documents in conflict therewith are later provided this headquarters to prove otherwise.
5. Upon proper determination by appropriate authority that the individual listed in this roster is no longer alive, and upon receipt from his legal heirs of a claim for arrears in pay and allowances due their estates, authority for settlement thereof under existing laws and procedures will be furnished your headquarters by the Director, Recovered Personnel Division, this headquarters.
6. This roster will constitute the only official recognized casualty roster, Missing in Action, of the II Corps, President Quezon's Own Guerrillas.
