1. The inclosed casualty roster, Wounded in Action and Wounded of Other Causes, of the Sulu Area Command, has been investigated.

2. This roster, consisting of three (3) pages and containing the names of one hundred twenty three (123) individuals, is approved. The period of recognition in each case will extend from the date of induction, date the unit was recognized or the date the individual entered a casualty status, whichever is appropriate, to the date the individual was released from service in the Armed Forces of the United States, both dates inclusive.

3. It is requested that the names and ranks of these individuals be inserted in the proper unit roster of the Sulu Area Command, by the issuance of appropriate orders.

4. All data contained herein are furnished on the sworn statement of the recognized guerrilla leader. They are accepted as official data upon which payments of arrears in pay may be adjudicated unless official documents in conflict therewith are later provided this headquarters to prove otherwise.

5. Upon receipt of a claim for arrears in pay and allowances from the individuals or their legal representatives, authority for settlement thereof under existing laws and procedures will be furnished your headquarters by the Director, Recovered Personnel Division, this headquarters.

6. This roster will constitute the only official recognized casualty roster, Wounded in Action and Wounded of Other Causes, of the Sulu Area Command.

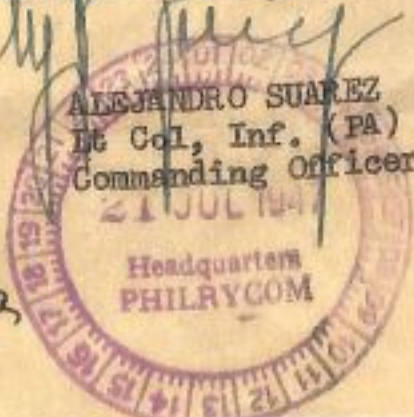
