The question of providing the Army with adequate funds thru the Currency Committee has given rise to a slight difference of opinion between the civil and military authorities with respect to the preferential distribution of the amounts that could possibly be ~~secured~~ <sup>received</sup> monthly, taking into account the difficulties of securing paper and other printing materials for the purpose. In this connection, I wish to inform you that to date, the Army has already received the following amounts from the Civil Government:

It is clear from the foregoing that the Civil Government has always given the Army preference in its financial requirements. You will also recall that out of the total cash collections of ~~various~~ <sup>various</sup> municipalities ~~in~~ <sup>in</sup> twenty-five (25) percent was given to the Army and only twenty-five (25) percent was taken by the Civil Government which was not even enough to cover its operating expenses.

in view, however, of the fact that the Civil Government would like to push through its relief projects, its financial requirements for the months of June and July, have become quite big, which nevertheless is less than the Army's requirement for any month. This caused quite a serious misunderstanding between the representatives of the Civil Government and the Army in the Press Area, which culminated in a conference between them in which the following agreement which was prepared by Maj. G. Francisco, the District Auditor of the Army, was adopted:

"1. In the conference had with Mr. Guzman, Deputy Governor Brind and Capt. Concesor this afternoon, I took up with them the contents of your Memorandum of May 16, 1943. As to the first point, I wish to state for your information that the members of the conference saw the reasonableness of turning over to the Army P700,000.00 monthly from the output of the Press, provided any amount printed in excess of P700,000.00 be turned over to the Civil Government or its authorized representative, without restriction whatsoever. I think this is best under the present circumstances. This, of course, depends upon the materials. Should there be a shortage of materials the first P500,000.00 that may be turned out by the press will be turned over to the Army and the rest to the civilian authorities.

"2. In this connection, Deputy Governor Brind called the attention of the members of the conference to the fact that the Governor is in need of P5,000,000.00 for relief measures and for administrative purposes. It has also been agreed in this conference that as soon as the Civil Government has reached its quota of P5,000,000.00 subsequent output of the press in excess thereof will go to the Army.

"3. It has also been agreed further that any amount which the Civil Government may need in the future once the quota has been filled may be given to it upon requisition from the Currency Committee.

"4. The work in the press is going on smoothly and the Currency Committee and the representatives of the Governor are sparing no efforts to push the project of supplying the Army and the civilian authorities of their needs. Everything in the press is in good order. This is due to the able management of the Currency Committee, Deputy Governor Brind and

Chief, Comision. From all appearances, I can safely conclude that he will be able to supply the needs of the Army and thus keep the morale of our enlisted men and officers."

This agreement was made in consonance with the instructions of Col. Reulida to Maj. Francisco as contained in his memorandum, dated May 10, 1945.

While the Civil Government may be able to go along with the amount of P250,000.00 every month from August to the end of the year, the Army insists on its priority over the first P700,000.00 that may be printed monthly. In view, however, of the scarcity of printing materials, the Civil Government has committed itself to give the Army priority on the amount of P500,000.00 per month only instead of P700,000.00 in accordance with the above agreement; but should there be enough paper materials, the Civil Government ~~will~~ give the Army the amount of P700,000.00 or more after printing the amount of P750,000.00 to cover both the shares of the Army and the Civil Government. It has been estimated that with enough materials, the press has a capacity of more than twice this amount. In view of the shortage of materials, however, the press could hardly turn out enough amount to cover all the requirements of the Army and the Civil Government aside from what has been agreed upon which Col. Reulida insists to get.

Due to my desire to go on with my relief projects, I have insisted on carrying out the provisions of the agreement entered into between the representatives of the Army and the Civil Government with respect to the proportional distribution of the output of the press. Col. Reulida, however, acting upon the orders of Col. Ferrita, insists that they should be entitled to more than the share which they have formerly agreed to take. According to Col. Ferrita, his minimum requirements is only P300,000.00 but the share that he gets is little less than twice the amount given to him monthly.

As you may have been informed, the relief projects which I am undertaking is not only for the civilians who have been suffering hunger due to the war but to insure enough food supplies for the Army also. With the money that I expect to get from the Currency Committee, I would be able to insure the cultivation of at least 100,000 hectares of rice land and 50,000 hectares of corn land to produce not less than a million cavannes of paddy and 150,000 cavannes of corn. To this effect, loans at the

Rate of P10.00 per hectare would be advanced in rice growers and P3.00 per hectare to corn. This loan will in turn be payable in kind after harvest at the rate of P3.00 per cavanna of either cereal, thereby giving the government more than 300,000 cavannes of rice and 50,000 cavannes of corn which is estimated to provide an army of 20,000 men with enough food supplies for not less than nine (9) months. At the same time there would be 800,000 cavannes of rice and corn which will be left in the hands of the producers for civilian needs. With this supply of food, the production of food crops for the succeeding period will not be a problem. This project will cost P1,100,000.00 which will be reimbursed in paddy and corn next harvest and will be at the disposal of the government. This project is intended primarily to insure food for the Army and at the same time the civilian population -- our brothers, sisters and every member of our families. In your travels during this emergency, you have no doubt come across, as I did many people with faces painted with hunger asking for any help that can possibly be extended to them. We are not at war because we in the government service alone might live. We are at war so that all may enjoy the blessings of prosperity common to all and for the glory of the principles of democracy entered to us as a common heritage of every Filipino. I understand that a major portion of the money which the Army needs badly will be for the payment of salaries of soldiers to keep their morale. To accomplish this end, I heartily concur. Let me state in this connection that with what the Civil Government has undertaken, and is still doing, for the success of our common aims, it also deserves to have enough amount for the partial salaries of its employees, most of whom have not been paid so far for the last twelve (12) months. It is needless to state here that they are just as active and vital parties in this war as the Army is and that their morale and will to go on with their work must also be kept.

The people -- our brothers, sisters, parents, and relatives -- are undergoing tremendous sufferings due to the scarcity of commodities of first necessity. Prices of the same have gone up beyond unbelievable proportions and became prohibitive even to those who counted with their fortunes before the war. Just think of bago-ong, formerly selling at fifty centavos a ganta, to be retailed at six pesos for the same quantity, laundry soap at twenty-five centavos a kilo to ten pesos, rice at twenty-five centavos per ganta to one peso, etc.

In the face of these cold and cruel facts, the bulk of the money that the Civil Government would get from the Currency Committee will be used for food production and for other articles of common daily use in humble homes, to which ninety-nine percent of us belong, and in the purchase of merchandise

...and doing merchandising ex-  
... Our objectives are to create a supply of commodi-  
... of first necessity adequate to meet our normal daily  
... demands and to organize and maintain a merchandising system  
... that would eliminate profiteering. Col. Reindia suggested  
... that a price control board should be created. I told him to  
... go on with his scheme with my cooperation and with the hope  
... that it might work. However, I informed him that even before  
... the landing of the enemy various control regulations have  
... been tried and enforced without practical results. On the  
... other hand, those regulations only enhanced other pernicious  
... practices of merchants which were greater evils than profit-  
... eering itself.

Some of the money will also be used to put up saw-  
... and oil factories by the use of animal drawn sugar mills.  
... if the funds would warrant, we may also undertake the leather  
... tanning project to provide at least some civil officials and  
... soldiers with shoes. Of course, we do not expect to supply  
... all the needs of everybody from these projects but I am quite  
... sure that these will do a great deal in maintaining equilibrium  
... between supply and demand. With plenty of money in circulation,  
... naturally, demand soars up and there must be enough supply to  
... meet such demand if we expect normal prices on prime commodi-  
... ties. These projects will help not only the consumers but  
... the producer as well. Market for copra will be created and  
... this will give livelihood to coconut owner whose families are  
... mainly dependent thereon. Handicrafts will also be revived.  
... Weaving of abaca and cotton clothers will be undertaken. Finished  
... products from southern towns have proven to be good. These can  
... easily be obtain in the northern towns of Ilocos and in some  
... parts of Cebu.

Without adequate supply of foodstuffs and other necessi-  
... ties, with an abundant supply of money paid to our soldiers as  
... salaries plus other funds available in the Army treasury for  
... the purchase of foodstuffs, prices would further go up to  
... still higher levels. Certain economic laws which are just as  
... immutable as those of physics are presently at work. The con-  
... ditions now obtaining have given rise to various economic and  
... social forces which would not be ignored. They respect no  
... earthly authority. Diligent enforcement of regulations di-  
... rected to that end will just encourage secret and illicit  
... transaction or put our what little business is presently  
... going on. Consequently, suffering would further be intensi-  
... fied, and vice would become rampant, for we would have plenty  
... of money with nothing to buy. People would go to gambling  
... and other kinds of vices. As I wrote Col. Reindia, we would  
... be creating a situation worse than under profiteering.

I am presenting these facts to you to apprise you of  
... my actualities in this regard, which is far from being selfish.

I hope you will understand that I have been doing my best and I am still ready to do anything for the Army. This is the reason why I have always considered the welfare of the Army as primary, over and above that of the Civil Government, in terms of money, food, labor, etc. You will recall that I have always fervently desired that our Army should exist and that I was opposed that your command in Africa should surrender when the order to surrender was issued. It was for this reason that I organized the emergency Provincial Guards with the hope that another Army would exist had the remnants of the 6888th failed to reorganize. This organization was being well before you have time to reorganize and that many Army men joined the organization. Not a few former members of the Provincial Guards are now high officers in the Army.

I hope I have other ways of making myself clear in letting you understand that I will be the last man to do anything that will tend to destroy our Army and will be the first one to do anything I can for its good. If there was misunderstanding between your men and mine in the field, it was because of the sudden change in certain procedures which we have to adopt to conform with existing conditions, but not because we have been unwilling to cooperate.

We are all soldiers fighting for the preservation of democracy. Each and everyone one is entitled to know the facts and figures that affect our common welfare in general and our individual interests in particular. You should know what your Government is doing for the common good, and what it is endeavoring to accomplish for the individual well-being of every soldier in the field. We have been laboring under very difficult and hard conditions during the last fourteen months, but thank God, we have successfully prevented the enemy from achieving its objectives in France. This is due to the patriotism and abnegation of every soldier, under the able, unflinching and wise leadership of Col. Curtis P. Deane, Jr. and the equally able, self-sacrificing and patriotic members of his staff.

The next coming months will be very very hard for you. Rest assured, however, that the Civil Government and the civil officials together with the people will always be behind you until the day of victory shall have arrived.

## MEMORANDUM -

All CT Comdrs

1. The present situation, wherein shortage of food is inevitably felt by both the ARMY and the civilians, our efforts must be turned to the utilization of every means to stave off such calamity, which is the hardest to resist - FAMINE. In many instances, under the guise of necessity, some of our men have gone unreasonably far as to commandeer seedlings of farmers. This is nothing short of destroying the hen that lays the golden eggs.

2. Thru earnest effort and full utilization with understanding of service of Civil Officials, Lt-Col GRASPARIL, of 66th Inf CT, has gone far in this regard. In fact, the Island Governor has taken cognizant of the success Col GRASPARIL has attained in tying-up his military mission with that of Civil agencies.

3. It becomes your challenge to do likewise, which we are sure you are doing your best. As a corollary to maximum encouragement in the production campaign, it is expected by the DC that every Army man should endeavor to utilize every spare second of his time to planting something that is edible - camotes, bananas, camoteng saho, corn, and even palay, wherever he may be located or assigned. The idea that we are mobile should not presuppose that such planting is useless, because you yourself could not avail of it. Sure, if you plant, at least the civilians living in the locality where you planted would be saved from hunger.

4. In many occasions where necessity demands, commandeering of food has been misunderstood by owners and civil officials, because of poor approach and non-compliance to our instruction to issue at all times receipts, whether the supplies are paid in full, partially, or totally commandeered. CT Comdrs are, therefore, reminded to correct these defects by proper issuance of instruction, checking of such, and punishing of offenders.

5. Quoting a portion of the letter of Gov CONFESOR to Col. GRASPARIL, this official statement of the highest Civil official in PANAY, reads:

"I have no objections to commandeering if you think that the procedure would serve your purpose. I know that this has got to be done under reasonable circumstances during war times. However, I simply want to it that the rights of the people are protected by giving them receipts for commandeered goods and commandeering officer should see to it that the people are not deprived of their right to live by getting including those that they keep for seedlings for the next planting season as it happened at various times in Antigua. Provided this is taken care of I'll say "Go Ahead."

Unit Comdrs must interpret this statement with understanding, and liaison their activities in this regard with Civil Officials concerned so as to promote better understanding between the ARMY and the CIVIL AGENCIES of the Commonwealth Government. You will notice from this statement the very interpretation by the highest Civil Official in PANAMA of the grounds wherein military necessity could be availed of to the extreme.

Unless the contrary is proven, Dist Hqs presupposes that all Officers are men of unquestioned loyalty and honesty, and those charged with the control of men must exercise their capacities as they shoulder the responsibility of acts of their subordinates.

6. We are nearing, in a way, the very goal of our sufferings, prospect of near victory is enough cause for us to put effort, seriousness in all matters which affect our Organization, and that of the people to whom, we have without orders, found fit to protect.

7. With Gen EISENHOWER Invasion Forces fully secure in northern FRANCE, Allied Armies in ITALY advancing fast after the capture of ROME and are now nearing the City of FLORENCE, with Admiral HALLIGAN's Pacific Fleet now having foothold in the MARIANAS, Japanese Mandated Islands, threatening to push through his announced plan to connect with Allies Armies in CHINA, and with Gen MacARTHUR's Forces fully occupying BIAK ISLAND, 900 miles from the PHILIPPINES and with the full utilization of super-bombers, Allies latest deadly weapons, nothing short of SURE VICTORY is coming, but within a turtle sense must prepare and look forward to 1945.

8. The productivity, morale, cooperation and help of the civil populace is what we must sought and encourage. The past months have been trying indeed where war in its stark reality having caused a lot of extreme sufferings on imaginable.

9. District Hqs is helpless to correct a lot of problems existing in your CTs unless such are reported to us, giving details and your recommendations, fundamental of them are the scarcity of food and the ever-increasing prices of prime commodities. As to the first, we can only remedy the future by going back to the farm and do our share. As to the second, CT Comdrs are asked to make a study of the following questions:

(1) How can we effectively control prices of prime commodities?

- (3) Shall we also control other interrelated factors such as production of food, its dispositions etc.

Result of your study should be submitted to reach the DC by 31 July '44 if possible, earlier. Suggest that you take this matter up with the nearest highest Civil Official in your area so that we, too, could take advantage of their experience observations and recommendations.

1. In connection with the drive for the benefit of the families of Army personnel and prisoners of war who are at present without funds and are not in a position to solicit help from others, we are quoting hereunder a portion of the letter received by the CO, CP-1, from Mrs. T. Ford, in charge of the drive for the province of CAPIZ, dated 26 April '43:

"It would be easier to collect funds from the people if they would be allowed to contribute in the form of palay, because majority of the people have much palay but little money. In this connection, I would like to suggest in behalf of the people of CAPIZ- especially of the poor, that the Army buy the palay, a considerable quantity of which is in the hands of the people, on account of the fact that there are no buyers in their localities. Such purchases could be made at the rates, that is ₱4.00 per cavan of palay, at which similar purchases are being made by the Army in ILOILO, particularly in the town of PASSI. Payments could be made in this manner: ₱1.00 to be paid for each cavan upon delivery of the palay, another ₱1.00 to be paid after 3 or 4 months, and the balance to be paid after the war. I am quite sure that the above arrangement would be very satisfactory, in so far as the palay owners are concerned. At present the prices of prime commodities such as salt, soap and oil are sky-high and because of the absence of palay-buyers, the people are forced to exchange their palay for the commodities mentioned above- getting very little for their palay. Should the Army buy the palay from the people, the latter would then have money with which they could buy their necessities and the hardships that they are suffering now, will be greatly alleviated. Such an act of the Army will truly be a blessing to the people and they will be very grateful, knowing that the Army is looking after the interest of the people, and if in the past, the people have been cooperating with the Army in so many ways, they will after this be more willing and

1. Our attention has been invited to the practice of some Army Units of grabbing the produce of properties under the administration of the Land Administrator. In some instances, the soldiers use intimidation and force to FORCE the tenants or overseers to release to them the produce.

2. In this connection, it is being informed that administered properties (Land & Haciendas and Fishponds) are placed under the Offices of the Land and the Fishpond Administrators. These two units manage the said properties and ACCOUNT for the produce that is derived thereat and which is applied to the benefit of the ARMY. In the FINAL accounting of these properties in the future, these offices will be held responsible.

3. It is then recommended that Units under your command be instructed to REQUISITION whatever supplies or produce from the Army Administered properties with the Office concerned (OLA or Admtr of Fishponds), for proper recording and accounting of such produce and withdrawals. Further, it is suggested that the Units under your command sign receipts for the supplies received. This way, our intention of PROTECTING the interests of the owners can be realized. This way too, you will be assisting the OLA and AF and this Office in keeping a straight and accurate record of such properties which in the end will be used to protect the good name of our Organization.

1. Reports reaching this Hqrs indicate that the practice of soliciting supplies and money from civilians by units or individual officers and men is still happening, in spite of prohibition to that effect.
  2. Some officers have been found to be writing friendly letters to civilian proprietors, begging for "supplies for their units". This places the whole Army Organization in the category of dependents or beggars.
  3. It has been the purpose of this Hqrs to centralize the procurement of supplies and funds to responsible officers, supplies to be officially received by BGM officers, and funds by Finance Officers. Following this procedure, any officer or unit who is the recipient of voluntary contributions or who, because of necessity procure supplies directly from the people, must report such matters to the Supply Officer or Finance Officer concerned, so that same could be taken up officially in their Book of Accounts.
  4. Therefore, while it is not intended to curtail individual civilian corroborators to give a share to any officer or unit, it is desired, as a matter of policy, to have those reported officially so that we will not be the recipients of anomalous charges that such goods have been converted for personal use.
  5. The practice of soliciting funds or supplies by individual officers and enlisted men not authorized must be STOPPED. In cases where civilians give directly any such supplies or money whether voluntary or as a loan, such matters must be reported immediately to the corresponding Supply or Finance Officers; otherwise, the Receiving Officer will be liable for court-martial for violation of this instruction.
  6. If Supply Units or Finance Officers could not meet your needs after having presented such to them, the case must be referred to TUNIS Headquarters.

PER CENT (80%) of our soldiers are not clothed or where clothing are available, they are not justly distributed. I will cite here a case. Before July 15, 1943, instructions were issued to our S-4 to requisition for clothing. We knew that there were clothing then. But we were not issued for reasons that we do not know, or we were not informed. We found out that other units were issued some clothing and shoes. Not until I personally went up the mountain were we issued a number. This is clear case of instance where inequity in supply distribution foil a good system on paper in the execution of our duties. We only request the Colonel to look clear into the situation.

4. There is a doubt by our superiors of our integrity as Officers. We request anybody to file court proceedings against us for any crime they may have suspected us to have committed. This so much talk of some people make the worst of some of us. This, we request that our superiors should consider things in the light of facts. We would also inform the Colonel that we are not opportunists who would like to amass wealth because we are in a position to do so as many of our Brother Officers did. If other Officers have been guilty of so many anomalous acts with the end in view of filling up their bodegas or establishing a ranch, we beg to inform the Colonel that we do not want to get rich so quick. We could have acquired wealth already in Sara before the Division was still there were we to like getting rich in so short a time. But as we reiterate, we are not the Officers who would develop fats by somebody's pockets as one of our Brothers did.

5. We seem to understand that Higher Headquarters are not informed of the FIELD CONDITIONS. We reiterate it here that the supply and financial status of the units in the field are below par. Communications and instructions on supply and financial phases are issued from time to time but they seem to carry us to nowhere. Again I will cite a case where the poor soldier who had lost his life in this noble struggle is forgotten. Here is a wife of a soldier who was killed in action. This same wife applied for a pension having also accomplished all necessary papers. For months, she had waited for the dreamed pension but the realities seem to be still the question. Here is an officer who has some questionable behaviour, clear to the eyes of the many to have been spending money right and left as if it were nobody's business. Yet here is the poor wife in waiting. Were are we on this?

1. Reports reaching this Hqs indicate that Officers of PARIS-40, specifically Capt HIPOBIA, Lts VELASCO and GANZON, have been soliciting voluntary contributions, both in supplies and funds from civilian owners. This practice has been ordered discontinued, ever since Supply Units and Finance Officers have been assigned in the field to carry this work. I would like you to find out if these voluntary contributions as solicited by individual officers are properly accounted for and disposed of.

Section 3, par 2 - DEFINITION AND GENERAL FUNCTIONS OF THE STAFF - a. The staff of a unit consists of the officers who assist the commander in his exercise of command.

b. The staff secures and furnishes such information as may be required by the commander, prepares the details of his plan, translates his decision and plan into orders, and causes such orders to be transmitted to the troops. It brings to the commander's attention matters which require his action or about which he should be informed, \* \* \*

\* \* \* for the consideration of the commander. Within the scope of its authority, it supervises the execution of plans and orders and takes such other action as is necessary to carry out the commander's instructions.

c. The staff officer should have a thorough knowledge of the policies of his commander and should be acquainted with his subordinate commanders and their units. A staff officer should be an active, well-informed assistant to the commander and a helpful advisor to subordinate commanders.

Section 3, par 4 - ORGANIZATION - a. Basis. - The organization of a staff is based upon the duties of the commander. \* \* \*

(1) The duties of all commanders can be divided into four principal functional groups as follows:

- Personnel.
- Military intelligence.
- Operations and training.
- Supply and evacuation.

(2) These 4 subdivisions of command duties, under

elements required immediately by the commander for tactical operations; and the rear echelon, of the remainder of the staff required for administrative activities.

"Section I, par 5 - COOPERATION - a. Teamwork is essential within and between staffs and between staff and troops. It is assured by cooperation and collaboration within and between all sections of the general and special staff groups, between the staff and troops, and between the staffs of subordinate, higher, and adjacent units. Prompt dissemination of essential information and of decisions and orders within and between groups is vital to the efficient functioning of a command.

b. The general staff group should consult the special staff officers as to the ability of their respective arms and services to execute contemplated missions, and give the special staff timely warning of operations in order to permit preparations.

c. Conferences of the staff including available subordinate commanders are often helpful. At other times individual personal contact is a more effective and practical procedure.

"Section I, par 6 - AUTHORITY - a. A staff officer as such has no authority to command. All policies, decisions, and plans whether originating with the commander or with the staff must be authorized by the commander before they are put into effect. When a staff officer by virtue of delegated authority issues an order in the name of the commander, responsibility remains with the commander even though he may not know of the order.

"Section IV - STAFF RECORDS, MAPS and REPORTS, par 41. STAFF RECORDS. - a. A system of staff section records is essential in order to have information available for-

- (1) Command decisions during operations.
- (2) Higher headquarters.
- (3) Historical records (AR 845-106)

b. The refinement of the system of making and keeping unit or staff records will vary with the factors of available time, opportunity, and personnel.

Par 42. OFFICE OF RECORDS. - a. The office of records is that of the adjutant general or adjutant.

b. Staff sections temporarily retain copies of documents needed in their current work, returning them to the office of records when no longer needed."

5. Slight deviation may be allowed in carrying out the provisions of the plan to meet peculiar local conditions. Major changes must, however, be first approved by this Hq. before they are made.

6. Notify this Hq. as soon as this plan is put into effect.

**MEMORANDUM ORDER .**

For all Deputy Governors  
Municipal Mayors and  
Other Civil Officials

See: Declaration of principles and Policies and Definition  
of Objectives and rules of Action Governing Relations  
Between the Civil Government and the Army.

\* \* \* \* \* Promised on the foregoing principles and policies, the Civil Government has defined as it is hereby defined in the following the rules of action and objectives in its earnest endeavor to cooperate loyally with the Army.

1. The Civil Government and the Army are both vital and active factors in this war. One is just as necessary and essential as the other to defeat the enemy. Consequently, each entity should bend all its efforts, in harmony and in mutual cooperation, towards the successful prosecution of the War to a victorious end. Altho, each is an independent organization, yet they should not work at cross purposes. Their activities and efforts should be properly coordinated to achieve their common end -- VICTORY.

2. The duties and responsibilities of the civil government and its officials to the Army are the following:

- a. To provide the Army with adequate food supply;
- b. To provide the Army with adequate labor supply;
- c. To help the Army gather information of military value;
- d. To help the Army insure its safety;
- e. To help the Army facilitate its movements and the execution of its plans;
- f. To help maintain public confidence on its integrity.

3. Deputy Governors, municipal mayors and food administrators should therefore exert every effort to meet the reasonable requirements of the Army with respect to food. Red tape in this regard should be avoided. The food supply for the Army in every municipality should be distributed at strategic points and the persons charged



occasions go beyond the scope of their authority. A few young men in uniform, especially under conditions obtaining during a period like this, find it difficult not to be over conscious of their importance. Consequently, they overshoot their mark very often. Under the cloak of Army discipline blindly, and at times maliciously execute their orders throwing prudence, common sense and every sentiment of human consideration to the winds ignoring thereby the evil consequences of their actions. Still there are those who by association and training are haughty and autocratic. Whether in the Army or outside, they do not know how to deal with their fellow men. They will not get along anywhere.

Despite all these faults and shortcomings among a number of men in the Army, civil officials are not relieved of their duty and responsibility to cooperate in every way possible with the Army. Certain individuals may be dispensed with by the Army, but we cannot do away with the Army. As above stated, the Army is a vital factor in this war.

Consequently, we should be liberal and broad-minded in our dealings with Army representatives. We should be tolerant to the faults and shortcomings of certain individuals therein. We should give wide allowance to the defects and delinquences of a few Army men. For we would seriously jeopardize our common cause should we not endeavor to defend and protect its integrity and prestige. It would be a tragedy should the ~~war~~ war come when Army men would be looked upon with distrust and fear by the ~~common~~ general pop.

However, every abuse by any Army man should not be allowed to go unpunished. To this end, abuses committed by any member of the Army should be reported immediately to his superior officers specifying the charges against him. Charges may be filed directly by the tenant del barrio, the Mayor or Deputy Governor concerned. Copies however should be furnished this office for our information and guidance.

This office has the assurance of the Commanding Office in Ponce and San Juan that every Army man found guilty of any irregularity or abuse of authority will be punished accordingly. Action taken on various cases reported to proper Army authorities vouch safes his assurance.

3. Should a civil official entertain a difference of opinion with an Army representative on certain questions of public administration, he should endeavor in an amicable manner to come to a working arrangement with the latter. Failing to accomplish it, he and the Army Officer should not try to settle the question in their own personal way. On the contrary, the civil officials should report the case to his superior officer, and the Army man should do likewise, for the final settlement of the question at issue.

In this regard, civil officials and Army representatives should come together as often as possible to discuss common problems. Even there are no question at issue frequent contact between Army and civil officials are always productive of harmony and mutual understanding.

In dealing with Army authorities and men, especially in an official way, utmost courtesy should be observed on the part of the civil officials towards the former. Oral discussions or written communications addressed to Army officers and men over certain public questions should be couched in a respectful language. Abusive and harsh terms are out of the place. In discussing controversial matters all civil officials are hereby enjoined to be calm and serene. They should never lose their temper. They must keep their heads cool.

In the administration of private properties, ...  
 suspects, of enemy subjects, of ...

this office has taken the following stand as embodied in its memorandum to Mayor Diasnes, dated May 6, 1943:

" X X X In my letter to Col. Rebusis, dated May 2, 1943, I have explained the position that the Civil Government has taken thereon as follows:

"1. In case of fishponds owned by absentee landlord, who with no fault of their own but are now outside of Panay, their property rights therein should be fully protected irrespective as to what who administers said fish ponds. I have no objection to Army administration of those fish ponds.

"2. That irrespective as to who administers the fish pond the Army should have prior rights over their output of fish. However, every effort should be exerted not to deprive the communities within a certain radius of those fishponds with a certain portion of said output.

"3. That the amount of fish that the Army may get to meet points to supply any of their units although the jurisdiction of the Administrative District where the fish ponds are located."

" X X X X If just compensation has not been provided for by the Army on the output of fish taken by it, the question is simple for instead of taking over the administration of said fish ponds from the Army and requiring them to submit their requisition for fish to the civil authorities, you or the parties directly interested should have sent representatives to the fish ponds to fix the price of any amount of fish chargeable against the Army in favor of the owners or the lessees thereof. These representatives may at the same time see to it that the properties in question are properly administered and proper accounting thereof is rendered on the output of fish turned over to the Army. X X X X In the case of Simplicio de la Peña, et al. who are lessees and whom you alleged to have been deprived of the rentals of certain fish ponds, they may make representations to the proper Army authorities, thru your office or thru Dep. Gov. Gelez for proper accounting of any fish that the Army may have taken to protect their lease rights. In these cases where the lessors have been considered by the Army as enemies thereby subjecting their properties to confiscation as spoils of war or booties, or otherwise, neither the Army or civil authorities can claim more rights than what said owners or lessors of the properties in question may have, which is the naked ownership of said properties during the life time of the contract of lease. The contractual rights of the lessees who do not have any dealing with the enemy should the afore be respected. This is the kind of private right which neither the Army nor the civil authorities have the right to destroy. The impairment of obligations of contract is a well known prohibition in the bill of rights of our constitutions. Most that the Army or the civil authorities, in the case may be, can expect thereby is to demand for the rentals accruing and payable to the lessors who are considered by the Army as enemies. Since, however, as the Army needs the fish that are produced from said fishponds whatever amount of said fish is taken therefrom by the Army should be accounted for and deducted from the rentals due and payable by the lessees to the lessors. In the amount of fish taken by the Army exceeds the rentals due the payable, said excess should be paid to the lessees if the Army is in a position to do so in cash or make proper receipts thereof. If this simple procedure is adopted, I do not see where there could be any source of misunderstanding between you and the Army authorities. The Army gets the fish and the lessees get paid for the same. I think that this arrangement will hold good in other kinds of properties similarly administered."

11. The foregoing constitute the basic rules of action prescribed for civil authorities in their relation with the Army. Strict adherence thereto is hereby enjoined. In their application, however, each deputy Governor is given freedom to use his discretion, taking into account conditions and circumstances obtaining in this district. To this effect

endeavor to enter into a working agreement with the commanding officer of the Army on his district.

12. Looking to our relations and dealings with the Army, we should always keep in mind that we have before us in Pansy and Remblon a big task and a tremendous responsibility. officer as a golden opportunity to demonstrate to the world our capacity to run and maintain successfully a self-governing democracy, as honestly as could be humanly accomplished, although under the most inauspicious circumstances now obtaining. At this juncture, our only supervising authority is our conscience and sense of civic responsibility. Both the Army and the Civil Government are in Filipino hands, and not only this, we are holding responsible positions in both organizations, represent the mass composed of the common men of our country. We all have sprung forth from the average Filipino home, modest and humble, but verile and noble, prizing dignity and honor over and above all other considerations.

We are, therefore, in the crucible. We should not fail. We must not fail. On the contrary, we should and must succeed. This should be the foremost consideration in our minds in the administration of the Civil Government in Pansy and Remblon. Forget petty jealousies and selfishness. Throw them into the scrapheap. Hence forth each and every one of us should solidly and unselfishly put his shoulder to the wheel, cooperate whole heartedly and loyally with the Army, to win the VICTORY for democracy in general, and for the common man of the Philippines in particular.

This memorandum order takes effect on this date, and repeals any order, regulation and or instruction by this Office contradictory to the provisions hereof.





These two units managed the said properties and ACCOUNT for the produce that is derived thereat and which is applied to the benefit of the Army. In the FINAL accounting of these properties in the future, these offices will be held responsible.

3. It is then recommended that Units under your command be instructed to REQUISITION whatever supplies or produce from the Army Administered properties with the Office concerned (OLA and Admtr of Fishponds), for proper recording and accounting of such produce and withdrawals. Further, it is suggested that the Units under your command sign receipts for the supplies received. This way, our intention of protecting the interests of the owners can be realized. This way too, you will be assisting the OLA and AF and this Office in keeping a straight and accurate records of such properties which in the end will be used to protect the good name of our Organization.

Dear Governor:

The rice harvest in your district will soon be in full swing. The palay problem, then, will be solved. But the fact that the heavy rice producing towns in your district are occupied by the enemy, the chances are, that the enemy might confiscate or collect all the rice from civilians. We do not want, if possible, that any rice will fall in the hands of the enemy - we are pretty sure, you will agree on this. We believe on your influence and ability as Governor, and we have a complete trust on you, to have a complete control on any tendency of the civilians to let their palay fall in the hands of the enemy.

Our Depot QM, Capt. Simpas, is directed to confer with you with a view to adapt ways and means by which the surplus palay of the civilians will be given or turned over to the Army. We pay cash for all the surplus. The funds intended for the procurement of palay is about to be due, in fact Lt. Pedrinia was sent to the Division to withdraw the necessary amount and is now in his way back. We trust that you will instill in the minds of your people that spirit of patriotism to our cause, which we know you are an ardent advocate.

As a CO of this organization, I am frank to state without the slightest reservation, that

tributions to the Armed Forces, assigned to this district, in spite of the economic deficiency of your people, and its proximity to the enemy. On this, you have my regards and respect.

The success of our men in your district, to accomplish their mission solely lies on your untiring cooperation.

In the absence of cash, we believe that by virtue of the proclamation of the Governor of Panay, you are vested with indefeasible rights to effect commandeering of cereals - to be paid subsequently. Funds for this purpose are either from the Army or civil authorities. If our funds arrive we will deliver to pay the obligation incurred by your office or our Depot.

Believe me, it is my ardent desire to see personally my old friend Gov. Maza and to remind him of the "Tri-pod" which you might have forgotten. Pressure of the work have barred me from doing so. I am delegating Capt. Simpas to make necessary arrangements and negotiations with you as regards to the procurement of palay. His acts pertaining to the procurement of palay are binding to me. Please allow him an audience with you. He carries complete instructions with him from me. The perfection of the suggestions to be made by him will, of course depend on you.

We know you are the most persistent Governor in your province, evidenced by your accomplishments in the past, both for the benefit of the Army and the civil populace. Your ability, influence and intelligence, we know, will never let our desire fail. We entirely bank on you for the subsistence of the Army in this coming year. This is a great responsibility and too much of work for you but for a man of your caliber, we believe you will never fail.

I congratulate you, Governor Maza and hope you will display once more your sense of patriotism and brilliant accomplishments.

My dear Colonel:

This is the precise time to take advantage of the opportunity during the harvest time in the First Administrative District. Governor Maza submitted to me the plan of purchasing rice from the occupied area in Sibalum and bring them to the unoccupied area. According to him he can readily purchase the quantity of about 10,000 cavans in Sibalum if there is money for cash payment and for hauling purposes. According to him the current price of rice in the occupied area is ₱5.00 per cavan and the cost of hauling is ₱1.50 per cavan. To make this effective he has organized a battalion of cargadores in his district. 



Hereunder is a report of the result of the Special Mission given the undersigned to "Y" Depot *WM*, giving particular attention to T-*QM* Bugasong, which I have given every personnel a separate mission to campaign vigorously for the percentage of palay in the different barrios of the Municipality of Bugasong.

2. The following data is the result of their campaign and the total collection of palay which they have achieved individually from 29 Nov. '43 to 13 Dec. '43 is hereunder reported for your information and guidance:

3. The collection above stated was done from 29 Nov. '43 to 13 Dec. '43. I have given instructions to the T-*QM* incharge of Bugasong to send out personnel to the remotest part of the town and on actual observation at Pangalagan, Bugasong, I found out that there are still palay percentage uncollected; I have asked the aid of the unicipal Mayor to give aid to the T-*QM* personnel by supplying a detailed information re percentage uncollected. The Mayor has assured me of these and even called a meeting for the teachers to help collect percentages and give to the T-Depot the share for the army.

4. Checking the records of the T-QM, Laua-an, the total number of palay collected through percentage from 1 Dec. '43 to 14 Dec. '43 is 25 cavans and 5 gantas. 5. Checking the records of the T-QM, Barbaza, the total collection of palay percentage is 30 cavans and 6 gantas. The collection too has come to a decline ~~30 gantas~~ due to the fact that all percentage has been collected. Instructions has been given to personnel to exert efforts in locating caches of landed owners who might have kept their palay from the collectors for correct percentage.



To : All CO's, Depot QM, In the Field

1. Lt. Cofreros, Field Representative, Tunis 200, has his men scattered throughout this area. Very often his men could not requisition from the T-Depot in the area they are assigned. Hereafter, they are authorized to requisition direct from the T-Depot, but the issues should always be based on the scale of field ration issued by this Hq.

2. They may be authorized to requisition direct to the barrio tenientes but in such cases, knowledge or permission of the T-Depot in charge will be resorted to for purposes of records and accounting.

3. While his men are permitted to requisition direct from barrio tenientes the authority of the T-Depot in charge will be requested in order to effect the collection. Instructions from this Hq was issued to the different T-Depot in charge to the effect that no issue can be made out of the contribution of the people without the authority from this Hq. While this authority is sufficient, it is still necessary that their requisition be confirmed or be approved by the T-Depot in charge.

4. The personnel of Lt. Cofreros may locate rice in the possession of the different barrio lieutenants. If rice is located then they will ask permission from the T-Depot in charge before collecting the palay. Proper requisition must be made to the T-Depot.
