- "M" COMPANY - URDANETA, STA. BARBARA, MALASIQUI, SAN CARLOS, CALASIAO, DAGUPAN, BINMALEY, LINGAYEN, BUGALLON, AGUILAR, URBISTONDO, MANGATAREM, LABRADOR, SUAL, ALAMINOS, MABINI, ANDA, BOLINAU, BANI, AGNO, BURGOS, DASOL, and INFANTA, Pangasinan.
