For your information, all cases of this or similar nature always receive a guerrilla roster and archives cheek before being returned to your office.

It is believed pertinent to once again call stantion to the forwarding of Form SIOLs to this headquartore containing very meager information. From data contained in letter from your office dated 15 Becomber 1805, it is evident that information of great value, such as the allegation of service with Hunters H.O.T.C., was on file in your office but was not furnished this headquarters. Notwithstanding the Lowest of the Form SIOL (wherein last grade and organization is shown) contains the entry unknown.

Your letter of 15 December 1950 also makes reference to many cases of this type on file in your office. It appears that such cases have already been certified by the Department of the Mary and any period of guerrilla service was probably certified as a missing attitus under Section 5 of the Missing Persons Jot. Under these circumstances, this headquarters is of the opinion that no valid purpose would be served by a certification giving recognised gueryfile service, for the same period of time since both certifications would gut the subject in a canual by or pay status.


Dear Major Rinaldi:

This is in reference to your letter of November 11, 1950, returning Va Form 3101 without action in the case of the above captioned individual for the reason that individual had service in the United States Navy from June 3, 1914 to Becember 29, 19th; In statemet from 3101 executed on November 9, 1950, was referred to you as a result of a letter received from our Gentral Office which, in part, gave the following information:

- 1) That veteran enlisted in the Navy on June 3; 1941;
- That he became missing upon the capitulation of the Naval Command at Corregidor;
- 3) That an affidarit is of record in Central Office dated May, 9, 19th, executed by Francisco Santos and Lucio Folintan, Las Pinas, Risal, setting forth information that the veteran eserved as a Guerrilla in the Enutree BOUT Out: and was arrested by the Japanese Respei tat on November 29, 19th, and into the Company of the Company o

Our Gentral Office has requested that we obtain a complete resume of the veterant's military and civilian activities from law 7, 1982, to date of his death, including industrial history. Also, information as to whether he was an escaped or released FDW and whether or not he returned to military control.

Since the Many does not have any information of Querrilla Service performed by the individual, the Form 3100 was directed to your headquarters. We have many instances where individuals served in the Many up to the fall of Corregidor and Later upon being released and returned home, joined recognized Querrilla Units. Full information of the individual's service in Querrilla Units can only be obtained, in this case, from your headquarters.



In view of the foregoing, it will be expreciated if you will furnish this office with any information of this subject's extirties subsequent to the fall of Corregior. If not available, then please desire a copy of the affidavit referred to by our Central Office so that an investigation may be instituted to determine his true status during the Japanese occupation of the Philippines.
