P.O.W./C.I. : Book containing names of P.O.W - M/sgt Brill Folder 11

21 Feb. 1970

Gentlemen:

Ten (10) years ago an Air Force Master Sergeant Brill, stationed at Clark Air Force Base, Luzon, Phillipine Islands, WOCC "Rosie" O'Donnell, gave me this book containing the names of 489 P.O.W.'s with the following instructions:

"Sometime after I die and just before you retire this is to be sent to the War Department. I refused to surrender it to them but gave my word that I would get it back to them at the proper time."

I retire 1 April 70 and M/Sgt Brill died in the P.I. approximately seven(7) years ago. I am carrying out his request.

M/Sgt Brill explained to me that the names marked with an "X" were men who were taken from the camp and never heard of again. Those with a date are the men who died or were killed and in many instances the cause of death and location is also shown.

Following the P.O.W list is a short list of Next of Kin and addresses and scattered throughout the book is English-Japanese phrases, a poem from a 1941 Readers Digest and recipes for a corn salve and a foot care solution.

It is my understanding the MSgt Brill is interred at Clark A.F.B. and it was my understanding when I last saw him that his mother was living and is Mrs Nancy Brill, 2321 E. 23rd. St., Granite City, I believe Ill.

I don't know what value this will be to you other than historical value but MSgt Brill seemed to think that it would have far reaching effects in some type of future political negotiations.
