I have this date sent a negative report to the United States Veterans Administration concerning the alleged military service of the person named above.

A review of official records failed to reveal sufficient evidence to establish military service as a member of the Philippine Army in the service of the Armed Forces of the United States during the period 26 July 1941 to 30 June 1946. We will reconsider our negative report upon receipt of the evidence checked below:

- Proof of identity and service as a member of the Philippine Army in the service of the Armed Forces of the United States any time between 26 July 1941 and 6 May 1942.
- Proof of identity and service as a member of a recognized guerilla unit of the Philippine Army in the service of the Armed Forces of the United States any time between 7 May 1942 and 30 June 1946.
- Proof and circumstances of death occurring while a member of the Philippine Army in the service of the Armed Forces of the United States.
- Proof of the alleged serviceman's non-return to his actual place of residence established at time of entry into service.
- Proof of return to military control before 15 August 1945.

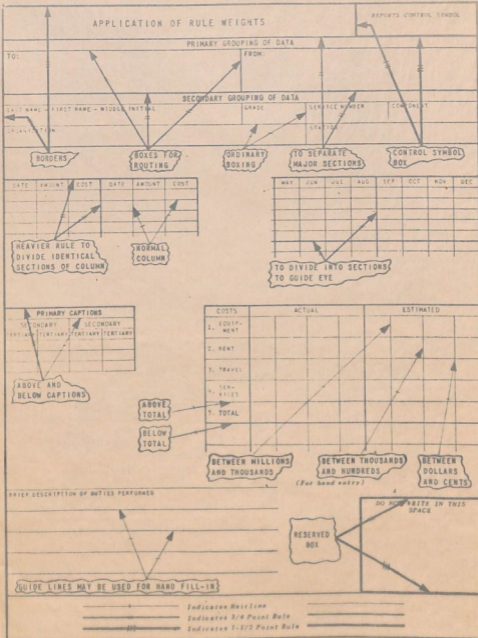


Figure 18. Application of rule weights.
